Sealed Proposals for DEPARTMENT OF PUBLIC WORKS YARD FUEL-ING STATION AT 25-33 DUPONT STREET will be received by the Borough of North Plainfield Municipal Building, 263 Somerset Street, North Plainfield, New Jersey, on August 16, 11:00 A.M. prevailing time, at which time and place they will be publicly opened and read aloud. No Proposals will be accepted after said hour. The contract scope shall include a fueling station consisting of demolition of existing buildings, asphalt pavement, concrete curbing and electrical improvements. The contract will allow ninety (90) calendar days for completion of the work from the notice to proceed. Copies of the Contract Documents may be obtained between the hours of 8:00 A.M and 4:30 P.M. daily, except Saturdays, Sundays, and Holidays, beginning on July 20, 2017, at the Municipal Clerk office of the Borough of North Plainfield, Municipal Building, 263 Somerset Street, North Plainfield, New Jersey 07060.

The cost for the Contract Documents is \$100.00 per set and is non-refundable. Payment for Contract Documents shall be by cash, money order, or certified check only and shall be made payable to the SUBURBAN CONSULTING ENGINEERS, INC. Contract documents cannot be purchased through the mail. The Borough of North Plainfield will not be held responsible for contract documents purchased via courier service.

Proposals shall be made on the forms provided and made part of the Contract Documents, which shall be submitted intact. A certified check or cashier's check made payable to the order of the Borough of North Plainfield, or a duly executed Bid Bond, in the amount of ten (10) percent (%) of each bid, but in no case in excess of \$20,000.00 must be deposited by the Bidder together with a Surety Consent evidencing that he can obtain the required Performance Bond.

The successful Bidder shall be required to comply with requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27, and deliver to the Borough an executed Performance Bond of a responsible indemnity company authorized to do business in the State of New Jersey. Proposals must be placed in sealed envelopes and delivered to the "MUNICIPAL CLERK," Borough of North Plainfield in the Municipal Building, 263 Somerset Street, North Plainfield, New Jersey 07060, clearly marked "DEPARTMENT OF PUBLIC WORKS YARD FUELING STATION" with the name and address of the Bidder marked clearly on the outside of the envelope. Bids received after the designated time and date will be returned unopened.
