North Plainfield Bulk Waste Program will be accept applications for Bulk Waste permits beginning March 15th for April and August 15th September Bulk pickup. When arranging for Bulk Waste appointments please remember:

- Appointments are reserved on a first come first serve basis and will only be made upon payment of fee.
- An application must be submitted with a non-refundable permit fee of \$10.00 per item up to \$50.00 for a maximum of five (5) items at the time of registration. Completed applications can be dropped off to the Department of Public Works Monday – Friday between 8am – 4pm.
- Applications will be available at *northplainfieldnj.gov* or can be picked up at the DPW office at Borough Hall.

COLLECTION GUIDELINE

Collection of materials will be made by Section according to the Borough of North Plainfield Collection Map. We are limited to the amount of stops per collection; therefore, it is on a first come, first served basis. Collection of materials will be random within each section; therefore, material must be placed at curb by 7AM on the assigned collection date. It is important that all materials be out by 7AM because collection moves quickly and your Bulk Waste will not be picked up if you do not have materials curbside prior. Please note that Bulk Waste pickup does not include metal. This is a separate pickup. Any unauthorized materials left at the curb in excess of the number of items scheduled and/or do not qualify for bulk waste pickup, must be removed by 6PM of the day collection is made. Failure to comply will be subject to the provisions of Section 14-8.5 of the Borough Code.

BATHTUB (no cast iron, faucet fixtures or cast iron) NIGHT-TABLE / END TABLE
WOODEN ENTERTAINMENT CONSOLE (dismantled and tied) TOILET BOX SPRING
