North Plainfield Bulk Waste Program will be accepting applications for Bulk Waste permits beginning March 15th for a one time annual pick-up for the month of April. When arranging for Bulk Waste appointments please remember:

- Appointments are reserved on a first come first serve basis and will only be made upon payment of fee.
- An application must be submitted with a non-refundable permit fee of \$10.00 per item up to \$50.00 for the maximum of five (5) items at the time of registration. Completed applications can be dropped off to the Department of Public Works between the hours of 8am – 4pm, Monday – Friday.
- Applications will be available on the web at [www.northplainfield.org](http://www.northplainfield.org) or can be picked up at the Borough Hall.

### **COLLECTION GUIDELINE**

Collection of materials will be made by Section according to the Borough of North Plainfield Collection Map. We are limited to the amount of stops per collection; therefore, it is on a first come, first serve basis. Collection of materials will be random within each section; therefore, material must be placed out at curb by 7AM on the assigned collection date. It is important that all materials be out by 7AM because collection moves quickly and your Bulk Waste will not be picked up if you do not have materials at curbside prior to established time. Please note that Bulk Waste pickup does not include metal. This is a separate pick-up. Any unauthorized materials in excess of the number of items sought for bulk waste pickup and/or which do not qualify for bulk waste pickup, which are left at the curb, must be removed by 6PM of the day collection is made. Failure to comply will be subject to the provisions of Section 14-8.5 of the Borough Code.
