2. The Borough reserves the right to reject any and all bids if it determines such rejection to be in the public interest.

The public sale shall be in accordance with procedures specified and, upon close of bidding, the highest bidder shall submit the full bid price in cash or certified check to the Borough Clerk within five (5) calendar days. Failure to submit will allow the Borough Clerk to seek payment from other responsible bidders.
4. No limit shall be placed on the number of surplus vehicles that can be purchased by any one bidder.
