**RESOLUTION NO. 07-13-15-01i** RESOLUTION OF THE BOROUGH OF NORTH PLAINFIELD AUTHORIZING EXECUTION OF AGREEMENT AND GRANT OF TEMPORARY EASEMENT FOR ACCESS AND CONSTRUCTION

WHEREAS, a project known as the Costco Warehouse, located on Route 22 East, Block 203.01, Lot 1 on the Tax Maps of the Borough of North Plainfield, was approved by the Borough of North Plainfield Planning Board by Resolution as to Application No. SPR-12-001 signed on October 11, 2012; and,

WHEREAS, Costco Wholesale Corp., through its authorized contractor, Graham Contracting, Ltd. ("Costco"), has requested a temporary easement for access and construction to perform an installation pursuant to the requirements of the Planning Board Resolution; and,

WHEREAS, the Agreement and Grant of Temporary Easement for Access and Construction (the "Agreement") provides for Costco's access in, along, under and through Clinton Avenue, a public roadway of the Borough of North Plainfield (the "Borough") and access and construction in, along, under and through real property known as 614 Warfield Road, Block 199.05, Lot 5, upon which is located a residential dwelling owned by Anthony Moglia ("Moglia"); and,

WHEREAS, the Agreement provides for the Borough and Moglia, as Grantors, to allow that temporary access and construction, to and by Costco, the Grantee; and,

WHEREAS, the Agreement provides for posting of performance and maintenance guarantees by Costco for the protection of the property of the Borough and Moglia; and,

WHEREAS, Costco has posted its performance guarantee with the Borough; and,

WHEREAS, the Borough Attorney/Director of Law Eric M. Bernstein & Associates, LLC, has drafted the Agreement in consultation with Costco and Moglia, containing terms pursuant to the requirements of the Planning Board Resolution; and,

WHEREAS, the Borough Engineer, Grotto Engineering Associates, LLC, by Senior Project Manager David J. Testa, P.E., C.M.E. has recommended execution of the Agreement by the Borough.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Mayor of the Borough of North Plainfield is hereby authorized to enter into such Agreement and to take all necessary steps to effectuate such Agreement and the Borough Clerk is authorized to witness such execution of the Agreement.

BE IT FURTHER RESOLVED that the Agreement shall not take effect unless and until all parties execute same.

# **RESOLUTION NO. 07-13-15-01k** RESOLUTION ENCOURAGING THE STATE TO RAISE THE TOBACCO PURCHASING AGE TO 21

WHEREAS, forty-two million Americans still smoke, resulting in tobacco use being responsible for nearly one in five deaths in the U.S.;

WHEREAS, because cigarette smoking and tobacco use are acquired behaviors, smoking is one of the most preventable causes of death in the U.S.:

WHEREAS, eighteen percent of adults place themselves and their families at risk for major and preventable health problems through tobacco use;

WHEREAS, eighty-five percent of daily smokers start smoking before age twenty one;

WHEREAS, there is an alarming increase in the use of e-cigarettes among teenagers and young adults:

WHEREAS, the Institute of Medicine found that increasing the tobacco purchasing age to 21 would reduce smoking by twelve percent, resulting in 249,000 fewer premature deaths, 45,000 fewer

lung cancer deaths, 4.2 million fewer total years of life lost among those born between 2000 and 2019, and fewer infants born prematurely;

WHEREAS, the journal, Tobacco Control, reports that underage smoking plummeted by nearly fifty percent after Needham, MA became the first municipality in the nation to raise the tobacco purchasing age to twenty one;

WHEREAS, the American Medical Association endorses raising the tobacco purchasing age to 21;

WHEREAS, municipalities across the country, including New York City and approximately eight New Jersey municipalities have raised the tobacco purchasing age to twenty one;

WHEREAS, Hawaii is the first state in the nation to raise the tobacco purchasing age to twenty one and other states, including California, have introduced similar legislation;

WHEREAS, on June 30, 2014 the New Jersey State Senate passed a bill raising the tobacco purchasing age to 21;

WHEREAS, the New Jersey State Assembly still has not yet passed the companion bill to raise the tobacco purchasing age, as the bill is still pending before the Assembly Health and Senior Services Committee;

WHEREAS, be it resolved by the North Plainfield Borough Council that we hereby request that the New Jersey State Assembly pass bill A3254 raising the tobacco purchasing age to 21, and establishing New Jersey as a public health leader in reducing underage smoking and preventable deaths.

## **REQUESTS FOR AGENDA ITEMS:**

The speaker concluded by voicing his concerns with the deliberate removal of a unique architectural feature from 51-53 Willow Avenue, further noting that the violation has yet to be corrected.

Mr. Merrill thanked all of the volunteers, specifically Joe Irovando, for their efforts with the Fourth of July parade and fireworks.

Mr. Righetti thanked those involved with the Fourth of July parade. Mr. Stabile offered accolades to everyone involved with the parade and the fireworks and noted the outstanding grand marshal of the parade, Mr. Righetti.

Council President La Ronde thanked Joe Irovando and the Special Events Committee members for their hard work on the Fourth of July events. He concluded by announcing the Borough-wide garage sale set for September 26 and 27.

Motion to adjourn by Ms. Miller, seconded by Mr. Singleterry and carried unanimously.
