WHEREAS, the Borough of North Plainfield and the Plainfield Municipal Utilities Authority are currently parties to a Shared Services Agreement, authorized under the Shared Services and Consolidation Act, <u>N.J.S.A.</u> 40A:65-1 <u>et. seq.</u>, for the removal and disposal of Type 10 Waste from the Borough of North Plainfield; and,

WHEREAS, the current Shared Services Agreement is set to expire on March 25, 2016; and,

WHEREAS, the Plainfield Municipal Utilities Authority has expressed an interest in renewing the current Shared Services Agreement for an additional one (1) year term, with the current pricing not to change during said additional one (1) year term and subject to the same terms and conditions as set forth in the current Shared Services Agreement between the parties; and,

WHEREAS, the Borough of North Plainfield is desirous of renewing the Shared Services Agreement with the Plainfield Municipal Utilities Authority for the removal and disposal of its Type 10 Waste from the Borough of North Plainfield for an additional one (1) year term, based upon the terms and conditions as set forth above.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey, that the Borough Council hereby authorizes the Mayor and the Borough Clerk on behalf of the Borough, to sign and/or execute the documents necessary to effectuate the one (1) year renewal of its current Shared Services Agreement with the Plainfield Municipal Utilities Authority for removal and disposal of Type 10 Waste from within the Borough of North Plainfield, which Shared Services Agreement is incorporated herein by reference as if same was fully set forth, without the need for any further action of this Borough Council.

RESOLUTION NO. 01-25-16-07b RESOLUTION OF THE BOROUGH COUNCIL AUTHORIZING THE MAYOR AND BOROUGH CLERK TO EXECUTE A SHARED SERVICES AGREEMENT WITH THE TOWNSHIP OF GREEN BROOK TO PROVIDE EMS COVERAGE AND SERVICE WITHIN THE TOWNSHIP OF GREEN BROOK WHEREAS, the Township of Green Brook is in immediate need for 24/7 EMS coverage and service; and,

WHEREAS, the Borough of North Plainfield has previously entered into an interim shared services agreement with the Township of Green Brook to assist the Township with its need for 24/7 EMS coverage and service; and,

WHEREAS, Fire Chief/Fire Director William F. Eaton has reviewed the ability of the Borough of North Plainfield to assist the Township of Green Brook with its need for 24/7 EMS coverage and service and finds that the Borough of North Plainfield has the capacity to enter into a shared services agreement with the Township of Green Brook to provide EMS coverage and service within the Township of Green Brook.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Council hereby authorizes the Mayor and the Borough Clerk to sign and/or execute the attached Shared Services Agreement with the Township of Green Brook to immediately provide EMS coverage and service within the Township of Green Brook, which shall remain in effect until December 31, 2016, with an automatic renewal period of one (1) year unless otherwise cancelled pursuant to the terms of said Shared Services Agreement; and,

BE IT FURTHER RESOLVED that the award is made pursuant to and consistent with the Local Public Contracts Laws of the State of New Jersey.

RESOLUTION NO. 01-25-16-07c RESOLUTION OF THE BOROUGH COUNCIL AUTHORIZING THE BOROUGH TO ENTER AN AMBULANCE SERVICES BILLING COORDINATION, TRAINING AND QUALITY REVIEW AGREEMENT WITH JFK MEDICAL CENTER AND THE BOROUGH OF NORTH PLAINFIELD FIRE DEPARTMENT

WHEREAS, The Community Hospital Group, Inc., t/a JFK Medical Center ("JFK") is in the business of providing mobile intensive care unit/advanced life support ("MICU") emergency services as necessary; and,

WHEREAS, Borough of North Plainfield Fire Department ("NPFD") is in the business of providing various patient transportation services, including basic life support ("BLS"); and,

WHEREAS, the applicable law requires MICU providers to enter into agreements with BLS provider to coordinate the billing of certain federal health care programs for such services; and,

WHEREAS, JFK is qualified to provide certain training and quality review services to the NPFD; and,

WHEREAS, the Parties desire that JFK provide certain training and quality review services to NPFD; and,

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey, that the Borough Council hereby authorizes the Mayor and the Borough Clerk on behalf of the Borough, to sign and/or execute the documents necessary to effectuate the three (3) year Agreement with JFK to: (i) facilitate compliance with the requirements for billing fee service for Medicare and Medicaid for ambulance services; and (ii) set forth the training and quality review services to be provided by JFK to NPFD, which Agreement is incorporated herein by reference as if same was fully set forth, without the need for any further action of this Borough Council.

WHEREAS, the Planning Board of the Borough of North Plainfield was directed by the Borough Council of North Plainfield to conduct a preliminary investigation in order to determine whether certain properties qualify as an Area in Need of Redevelopment, pursuant to the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1, <u>et seq.</u>; and,

WHEREAS, Paul Grygiel, AICP, PP prepared a report, entitled "Area in Need of Redevelopment Study – Villa Maria Site," dated November 2015, at the request of the Borough of North Plainfield Planning Board; and,

WHEREAS, on December 9, 2015, the Planning Board held a public meeting to discuss and consider whether the properties identified in the November 2015 report should be considered an Area in Need of Redevelopment; and,

WHEREAS, on December 9, 2015, after reviewing the November 2015 report and hearing testimony from Paul Grygiel, AICP, PP, as well as considering the testimony of members of the public, if any, the Planning Board determined that the following properties within the Borough of North Plainfield do constitute an Area in Need of Redevelopment:

RESOLUTION NO. 01-25-16-07e RESOLUTION OF THE BOROUGH COUNCIL ENDORSING THE DESIGNATION OF A REHABILITATION ZONE AS DESCRIBED IN THE MASTER PLAN ADOPTED ON APRIL 9, 2014

WHEREAS, on April 9, 2014, the Planning Board of the Borough of North Plainfield adopted a Master Plan in accordance with the provisions of the Municipal Land Use Law, specifically <u>N.J.S.A.</u> 40:55D-28; and,

WHEREAS, the Master Plan, adopted on April 9, 2014, recommends the revitalization of the downtown area, including adjacent residential neighborhoods, by designating this portion of the Borough to be an "area in need of rehabilitation," as described and permitted by the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1, <u>et seq.</u>; and,

WHEREAS, pursuant to the authority created by <u>N.J.S.A.</u> 40A:12A-1, <u>et seq.</u>, at the request of the Borough, Paul Grygiel, AICP, PP, has prepared an Area in Need of Rehabilitation Study of the Downtown Area, dated October 2015; and,

WHEREAS, as a result of the study conducted by Paul Grygiel, AICP, PP, at the request of the Borough, Mr. Grygiel concluded that lands located generally between Westervelt Avenue and Grove Street between Route 22 and the City of Plainfield qualify as "an area in need of rehabilitation" in accordance with the statutory criteria contained in the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40:12A-1 et seq.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Council, in accordance with the authority provided by the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1 et <u>seq.</u>, and as recommended by the Master Plan adopted on April 9, 2014, hereby designates as an area in need of rehabilitation property generally located within the Downtown Area of the municipality and as more specifically described within the Area in Need of Rehabilitation Study prepared by Paul Grygiel, AICP, PP, dated October 2015,
