MAYOR'S MESSAGE:

Mayor Giordano read his State of the Borough address as follows:

Happy New Year and welcome to North Plainfield's Annual Reorganization Meeting. I'd like to wish everybody a happy, healthy and prosperous 2017, especially my distinguished colleagues on the Borough Council.

This Reorganization Meeting has special meaning to me in that it marks the beginning of my third term in office. I want to thank the voters who've expressed their confidence in my administration by returning me to this office. And I want to thank them for returning a solid team of Council Members to this table – Councilwoman Keiona Miller, Councilman Skip Stabile, and Councilman Frank Righetti. But whether or not you supported us with your vote, I hope you take continued pride in what we've accomplished working together as a team and the progress we've made as a community. I hope that you look around our community and get a sense of what local government, working hard and working together, can accomplish for everyone's benefit.

I'm proud to say that redevelopment activity, investment, and progress in North Plainfield continued to be strong in 2016, and this trend will continue into the New Year. The planning and investments we made in previous years are strengthening North Plainfield today to make it a great place to live, work and do business.

Highlights of this past year include the opening, approval or construction of several new businesses in the Borough, most notably, the recently opened La-Z-Boy furniture showroom and the Kiddie Academy. Now under construction are the AAA Travel Store and Auto Repair Center, Metro Storage Facility and the Goodwill store. Approved, and soon to be under construction, are the Petco pet store next to the Texas Roadhouse Restaurant, Arooga Sports Bar and Quick Chek convenience store and gasoline station. Soon to be before the Board of Adjustment is a WAWA Convenience Store and gasoline station.

All of these developments serve to strengthen the Route 22 Corridor as a place to do business, shop and dine. All of them add to the convenience of living in North Plainfield and bring jobs to our economy.

The Borough also completed a number of road and sewer projects throughout the town, designated Rehabilitation and Redevelopment areas in accordance with the recent Master Plan, constructed a new salt storage facility and emergency generator at our Public Works Yard, constructed a new Downtown parking lot, planned for a new fueling facility at our Public Works Yard and, with action taken today, awarded a bid for an emergency generator at the Vermeule Community Center.

Planning Initiatives

As an outgrowth to our new Master Plan, the first new Plan in over 40 years, the Council has endorsed the designation of Rehabilitation and Redevelopment Areas. The Rehabilitation Area is targeted at the Downtown, and the Redevelopment Area is targeted at the long abandoned and run

down Villa Maria site. It is my hope that focusing on these areas will help to spur growth and new tax revenue for North Plainfield.

We also implemented a Government Energy Aggregation Program for the Borough. This is a process by which we solicit bids for electricity generation costs. The concept of energy aggregation allows our residents and businesses to voluntarily benefit from competitive pricing for their electricity use and encourages the increased use of renewable energy. Rest assured that any customer in the program remains free to shop for a better deal or withdraw from the program at any time. Information on this program is on our website and any consumer may still opt in to this program which will run through the end of 2017, at which time we hope to have another competitive contract in place.

Traffic Regulations

A safety initiative put into place last year was the elimination of many uncontrolled intersections in the Borough by placing Stop and Yield signs. The Police Department, Borough Engineer and Borough Administrator have worked extensively on this initiative and came up with recommendations for over 70 locations. I ask all of you, especially motorists, to be on the lookout for these changes and set an example by driving safely.

Recreation Department

Recreation and sports are a huge part of North Plainfield's tradition. Our varied programs have always been run well by a dedicated group of part time workers and volunteers. However, this past year the program has been enhanced further by the staffing of a full-time Recreation Director, Dennis Passe. Dennis coordinates our many part time staffers and volunteers to help bring even more Recreation services to our residents.

In 2016 for example we had our first free outdoor movie with a new and improved sound system, and we installed a new horseshoe pit and bocce court.

In the summer, we introduced "on line" sports registration to the community, complementing our new recreation web site. Our residents can now register for youth sports programs at their convenience from their home, office or smart phone.

Improvements were also made to our summer camp program which now features outside vendors providing educational activities every other week. This is in addition to our weekly camp activities and is provided at no extra charge.

For this holiday season, we created a community-wide house decoration contest and awarded gift cards to the top three contest winners. Additionally, our holiday decorations were expanded at Vermeule.

Special Events

Our Mayor's Special Events Committee runs several free events throughout the year for our residents. These events include the Memorial Day Services, 4th of July Parade, Summer Concert and Fireworks Display, Somerset Street Car Cruise, Senior Picnic, and Santa's Arrival and Tree Lighting.

This year the Committee introduced the North Plainfield Community Day featuring free bounce rides and face painting for children, two bands providing entertainment for everyone, and food vendors. The evening was capped off with our fantastic Fourth of July fireworks display.

In 2017, the Committee plans on expanding the Community Day with additional activities, providing free outdoor concerts on the recently renovated outdoor stage at the Vermeule Community Center, and will ask Santa Claus to tour North Plainfield the evening he meets children at the Community Center.

Fire/EMS Department

This year our Fire/EMS Department completed a full year of providing EMS (emergency medical services) services to Green Brook Township with great success. In turn, our Fire and EMS call volume will finish at approximately 3,400 incidents, well above the 2,834 from 2015. These additional EMS incidents also helped generate a record breaking year of revenue for 2016, which will finish just shy of \$500,000.

During 2016 the Fire Department finalized one of its capital improvement projects, which included full renovations to the apparatus floor. This project included the improvement to drainage and a new surface area to Bays 3 and 4 of the firehouse which will enhance safety.

Lastly, we did have one major fire of significance at the Regency Village apartment complex on a very hot weekend in July. Unfortunately, the fire took the lives of two local residents, but thanks to a strong County-wide mutual aid fire plan, the fast-moving fire was contained to the building of origin. On the whole, the fire department had a successful year in 2016.

Police Department

In 2016 the Police Department continued our successful Summer Teen Evening Program (STEP). We graduated our second successful Youth Police Academy for children in the 5th through 8th grades. National Night Out was the biggest so far with over 600 in attendance. The DARE program graduated 251 students. Our Gang Resistance Education And Training (G.R.E.A.T) program was well received with the 7th graders. Patrol officers responded to and deployed Narcan 15 times saving victims of drug overdoses.

On March 10, 2016, Chief William Parenti and Lt. Ed Ciempola testified before the New Jersey State Accreditation Commissioners and are happy to report the commission voted unanimously to approve the Police Department for a record third reaccreditation. The North Plainfield Police Department voluntarily submits to the process of Accreditation to demonstrate its willingness to be held to a higher standard. Maintaining accredited status is a highly-prized recognition, demonstrating the hard work being done by the men and women of our Department each day in service to our community.

Continuing to be one of the trend setters and to show our willingness for transparency, North Plainfield Police are now wearing Body Worn Cameras. President Obama began the call for police to wear these cameras, and in December of 2015 Acting Attorney General Hoffman announced \$2.5 million in grant funding for police departments to implement them. Our Police Department applied for and received funding for the cameras.

While not a cure-all for the problems we are dealing with in policing, they are a win-win for both police officers and the public. They provide a firsthand look at the dangerous situations officers encounter on a daily basis, improve transparency and build trust. They have a calming effect on both the officers and the persons involved knowing they are being recorded. North Plainfield Police will continue to embrace the latest policing trends to better serve our proud community.

Public Works

This past year we made significant improvements at our expanded Public Works facility, part of which was acquired from the Somerset County Freeholders in 2014 for the sum of \$1.00.

We constructed a new salt dome that is now operational which significantly increases our storage capacity. This facility was partially funded by the Somerset County Freeholders and will be shared with their Public Works Department to help support snow removal efforts in our part of the County.

We also added an emergency generator to the Public Works garage which will keep us fully operational during emergencies. As part of the salt storage construction, we removed contaminated soil at the site. This year I anticipate the construction of a new fueling facility and further improvements to enhance efficiency of this critical department.

Emergency Preparedness

Although we've been very fortunate this past year with regard to flooding, and have had a mild winter (so far!) we know, based on past experience, that we must be proactive in preparation for any emergency. We secured funding from FEMA for a generator for the Vermeule Community Center and this bid was awarded today. We previously installed two natural gas generators at the Public Works Garage which will keep fuels flowing and our radio station on the air in the event of a power failure. We also have a diesel generator at the Municipal Complex to keep it operating in the event of a power failure.

I would also like to again take this opportunity to encourage all residents, businesses and family members to sign up for our Alert Program which allows you to customize how you prefer to be reached, and the type of notifications you would like to receive, for emergencies, special events, etc. You can choose to be notified by phone, email, and/or text message — the choice is yours. It is essential to provide us with your contact info if you have an unlisted phone number and you wish to be notified about emergency information. Even if you don't live in town but want to be aware of alerts that may affect family members, you may use this service. Instructions on how to sign up can be found on the Borough's Webpage.

Infrastructure Projects and Community Facilities

We have been very aggressive over the past years investing in our community facilities and infrastructure. We have taken advantage of historically low borrowing costs and very competitive construction prices. I'd like to thank the Borough Council for being supportive of these initiatives. I will be presenting additional projects for their consideration in the spring as part of the annual budgetary process.

Our recent Sanitary Sewer Improvement projects include:

Geraud Avenue Pump Station Improvements, recently completed

Cypress Gardens Sanitary Sewer project, recently completed

Grove Street Sanitary Sewer Replacement, nearing completion

Dahlia Terrace Sanitary Sewer Replacement, out for bids

This past year we were awarded funding through the 2016 Community Development Block Grant program for the West End Sewer Improvements, which is currently under design.

Our recent Roadway Improvement projects include:

Resurfacing and other improvements to major routes including Warfield Road (entire length), Grove Street, Duer Street, Rockview Avenue, Rockview Terrace (entire length), and portions of thirteen other streets.

We recently completed the construction of a new parking lot at the corner of Somerset Street and Pearl Street. This will soon be generating additional revenue for the Borough as well as providing more convenient parking in our Downtown.

Next year we expect to have a new traffic signal constructed at this intersection which will include pedestrian signals to enhance pedestrian safety.

Upcoming Roadway Improvements:

The NJDOT recently awarded the Borough a \$180,000 Grant for the reconstruction of Norwood Avenue. This project is currently under design and will be constructed later this year. Thanks to the renewal of the State Transportation Trust Fund we expect that there will be twice as much money for these qualifying grant projects in the future. We eagerly await the opportunity to apply for these additional funds beginning next year.

With the recent endorsement of the Complete Streets concept by the Borough Council, there will also be additional benefits for pedestrians and bicyclists as we seek to make the roadways more accommodating and safe for those users. This endorsement has allowed us to obtain grant money for additional bike racks which are being placed at key locations in town.

Building Improvements:

We hired an architect who is currently developing plans and specs to re-design and modernize the main floor space at the Memorial Library. We expect that this project will go out for bid in 2017. Longer term we will be exploring installation of an elevator for this heavily-used facility.

This year we proceeded with plans to renovate the Upstairs Conference Room at Borough Hall and Hallway. This work is nearing completion with the installation of new flooring and carpeting. The rest of our Mayors portraits will soon be hung in the Conference Room.

2017 Annual Budget

We began the process of preparing the 2017 annual budget in November. The 2017 budget being proposed will maintain all essential services and be formally presented to the Council next month. As usual, the main upward pressures on the budget are costs that we cannot control – State Health Benefits Plan premiums, State Pension Plan obligations and property tax valuation losses due to outside economic factors.

We did well by benefiting from increased revenues due to economic development (especially in the US Route 22 Corridor), increased fees for EMS services provided in Green Brook Township, aggressive tax collection efforts, and receipt of our full State Aid entitlement due to achieving the highest possible category once again in the State's annual Best Practices Survey.

Personnel

I extend my thanks to our team of Directors and Department Heads, and the staff at Borough Hall for their hard work in the past year and their dedication to the Borough and its citizens. This also includes our legal team, headed by Eric Bernstein and his staff.

First and foremost among our Borough Hall staff are Borough Administrator David Hollod, and Administrative Assistant Gail Cain. Most every issue affecting the Borough comes through this two person office and their hard work and dedication shows through in every aspect of what we accomplish. One of the initiatives completed this year by Administrator Hollod, Chief Eaton, and Jim Rodino was the preparation of a new Personnel Manual for all employees.

A huge "Thank You" goes out to all of our volunteers serving as members of the committees, commissions, and advisory boards for your countless hours of service, especially to those members departing from our boards and committees. And congratulations are offered to all the newly appointed members who are needed for their fresh ideas and experience. All of you make my job much easier.

I look forward to working with the Borough Council, the Board of Education, the Somerset County Freeholders, state agencies, our neighboring communities, community groups, and our many volunteers to continue the progress we have made in North Plainfield. Time and again we have demonstrated the value of strong partnerships with these groups.
