RESOLUTION NO. 01-23-17-01a RESOLUTION DECLARING JANUARY 2017 RADON ACTION AWARENESS MONTH

WHEREAS, radon is a colorless, odorless, naturally occurring radioactive gas that threatens the health of our citizens;

WHEREAS, radon is the second leading cause of lung cancer deaths in the United States and the number one cause among non-smokers;

WHEREAS, one in fifteen homes across the U.S. has an elevated radon level;

WHEREAS, any home in the Borough of North Plainfield may have an elevated level of radon, even if other homes in the same neighborhood do not;

WHEREAS, testing for radon is simple and inexpensive;

WHEREAS, elevated radon levels can be fixed:

WHEREAS, the Borough of North Plainfield and the U.S. Environmental Protection Agency are supporting efforts to encourage Americans to test their homes for radon, mitigate elevated levels of radon, and build new homes with radon-resistant materials and features.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of North Plainfield that January 2017 is hereby declared as

OFFICIAL RADON ACTION AWARENESS MONTH

in the Borough of North Plainfield, and all residents who have not yet tested their homes are called upon to conduct such tests and to reduce radon levels if they are found to be elevated, to protect their families from the serious health risks of radon.

RESOLUTION NO. 01-23-17-01b APPROVAL TO SUBMIT A GRANT APPLICATION AND EXECUTE A GRANT CONTRACT WITH THE NEW JERSEY DEPARTMENT OF TRANSPORTATION FOR THE SANDFORD AVENUE ROAD IMPROVEMENT PROJECT

RESOLUTION NO. 01-23-17-01c RESOLUTION OF THE BOROUGH COUNCIL APPROVING FINAL PAYMENT NO. 3 AND CHANGE WORK ORDER NO. 1-FINAL TO AQUA INFRASTRUCTURE REHABILITATION CO., LLC d/b/a TRI-STATE GROUTING AND THE CLOSING OUT OF CONTRACT 2016-01, THE PROJECT KNOWN AS CYPRESS GARDENS SANITARY SEWER REHABILITATION

WHEREAS, the Borough of North Plainfield previously awarded contract 2016-01 for certain sanitary sewer rehabilitation improvements with regard to a project known as "Cypress Gardens Sanitary Sewer Rehabilitation" (hereinafter referred to as the "Project"), said contract having been awarded to Aqua Infrastructure Rehabilitation Co., LLC d/b/a Tri-State Grouting, with an address of 567 Walther Road, Newark, Delaware (hereinafter referred to as the "Contractor"); and,

WHEREAS, Kyle A. Smith, P.E., of Mott MacDonald (hereinafter referred to as the "Engineer"), on behalf of the Borough, has reviewed the Contractor's submission for Final Payment No. 3 in the total amount of Three Thousand Seven Hundred Sixty-Eight Dollars and Fifty Cents (\$3,768.50) and for the total closeout of the Project, which includes but may not be limited to, the release of any of the Contractor's retained funds held by the Borough and the execution of any maintenance agreement for the Project¹; and,

WHEREAS, the Engineer, on behalf of the Borough, has reviewed the Contractor's request for Change Order No. 1-Final, reducing the net amount of the completed project in the total amount of Eight Thousand Eighty-One Dollars and Sixty-Four Cents (\$8,081.64); and,

WHEREAS, Director of Law/Borough Attorney Eric M. Bernstein, Esq., and the offices of Eric M. Bernstein & Associates, LLC has reviewed the Engineer's and the Contractor's submissions and accepts same based on the recommendations of the Engineer.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the request for Final Payment No. 3, dated December 5, 2016, and closeout of the project known as Cypress Gardens Sanitary Sewer Rehabilitation to Aqua Infrastructure Rehabilitation Co., LLC d/b/a Tri-State Grouting, is approved in the total amount of Three Thousand Seven Hundred Sixty-Eight Dollars and Fifty Cents (\$3,768.50), which Final Payment Request and closeout request is incorporated herein by reference as if same was fully set forth within and payment for same is authorized to be made to the Contractor, without the need for any further action of this Borough Council; and,

BE IT FURTHER RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey, Change Order Request No. 1-Final, dated December 5, 2016, with Aqua Infrastructure Rehabilitation Co., LLC d/b/a Tri-State Grouting, is approved reducing the net amount of the completed project in the total amount of Eight Thousand Eighty-One Dollars and Sixty-Four Cents (\$8,081.64), which Change Order Request is incorporated herein by reference as if same was fully set forth within, without the need for any further action of this Borough Council.

WHEREAS, the Director of the Division of Local Government Services has approved NJ Tax Lien Investors/Real Auction.com to conduct pilot programs, and

WHEREAS, the rules and regulations authorize a municipality to submit an application for participation in the pilot program for an electronic tax sale, and

WHEREAS, an electronic tax sale is innovative and provides a greater pool of potential lien buyers, thus creating the environment for a more complete tax sale process, and

REQUESTS FOR AGENDA ITEMS:

Ms. Schaefer requested an ordinance to ban the sale of cats and dogs by pet stores. Mr. Stabile suggested discussion of an ordinance which would require cats be leashed while outside of their yards as proposed by a resident.

Mr. Righetti shared his concerns with kids riding bikes after dark without lights. The Council President concurred and noted his concerns with kids skateboarding on streets.

PUBLIC COMMENT:

Frank D'Amore, Sr., 40 Willow Avenue, North Plainfield, explained that the requirement for lights on bikes falls under Title 39. Sharing his concerns about the limited parking near the Post Office, he urged for an ordinance restricting parking in that area to fifteen minutes.

COMMENTS BY MAYOR, ADMINISTRATOR AND COUNCIL MEMBERS:

Mayor Giordano reported on his attendance at a Martin Luther King celebration.

Mr. Singleterry thanked Mr. Williams and Councilman Storch for attending the evening's meeting and speaking about mental health. Mr. Merrill echoed his sentiments.

RESOLUTION NO. 01-23-17-03 RESOLUTION OF THE BOROUGH COUNCIL AUTHORIZING THE MAYOR TO EXECUTE A MEMORANDUM OF AGREEMENT BETWEEN THE BOROUGH OF NORTH PLAINFIELD AND THE NORTH PLAINFIELD POLICEMEN'S BENEVOLENT ASSOCIATION SUPERIOR OFFICERS, LOCAL 85 AND A MEMORANDUM OF AGREEMENT BETWEEN THE BOROUGH OF NORTH PLAINFIELD AND THE NORTH PLAINFIELD POLICEMEN'S BENEVOLENT ASSOCIATION, LOCAL 85

WHEREAS, the Borough of North Plainfield (hereinafter referred to as the "Borough") engaged in contract negotiations with both the North Plainfield Policemen's Benevolent Association Superior Officers, Local 85 (hereinafter referred to as the "PBASO") and the Policemen's Benevolent Association, Local 85 (hereinafter referred to as the "PBA"); and,

WHEREAS, the Borough believes that it has come to an agreement with both the PBASO and the PBA as to material terms of each proposed new contract; and,

WHEREAS, the Borough now intends to enter into a Memorandum of Agreement between the Borough and the PBASO and a Memorandum of Agreement between the Borough and the PBA outlining the material terms to be included in each respective new collective bargaining agreement covering the period of January 1, 2016 through December 31, 2019, copies of which are attached hereto and incorporated herein; and,

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey, that the Borough Council does hereby authorize the Mayor to sign and/or execute the attached Memorandum of Agreement between the Borough and the PBASO and the attached Memorandum of Agreement between the Borough and the PBA without the need for any further action of this Borough Council, as well as authorizing the Mayor and Borough to sign and/or execute new collective bargaining agreements between the Borough and the PBASO and the Borough and the PBA without the need for any further action of this Borough Council.

BE IT FURTHER RESOLVED that the execution of these Agreements shall be subject to the Certification of the Borough's Chief Financial Officer as to the availability of funds for payment for same.

BE IT FURTHER RESOLVED that the award is made pursuant to and consistent with the Local Public Contracts Laws of the State of New Jersey.

Seconded by Ms. Miller and on Roll Call carried all seven voting aye.

Motion to adjourn by Ms. Miller, seconded by Mr. Righetti and carried unanimously.
