ORDINANCE NO. 17-01 AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT THE BOROUGH CODE OF THE BOROUGH OF NORTH PLAINFIELD, MOST NOTABLY CHAPTER 22, ENTITLED "LAND DEVELOPMENT" BY ESTABLISHING A PROFESSIONAL OFFICE OVERLAY ZONE ("O"), CONSISTENT WITH THE MASTER PLAN ADOPTED ON APRIL 9, 2014

The Clerk read the Ordinance by its title.

PUBLIC COMMENT:

Thalia Saloukas, 280 Watchung Avenue, North Plainfield, explained that Watchung Avenue had always been a residential gateway. Over the years, a decline in property maintenance has led to a decrease in the quality of life. Why impose a zoning change on an owner-occupied residential area? The increased traffic, illegal parking, stack housing, and crime will lead to decreased property values. She urged the council to reconsider and vote against the ordinance.

Bart Thomas, 26 Mountain Avenue, North Plainfield, voiced his concerns, specifically the potential increased traffic, on-street parking, and crime. Noting that he had lived in the area all of his life, he urged the Council to vote no to help retain the residential fabric of Watchung Avenue.

Frank D'Amore, Sr., 40 Willow Avenue, North Plainfield, questioned how the ordinance would improve North Plainfield and expressed his concerns with property maintenance enforcement.

Motion to close public comment by Ms. Miller, seconded by Mr. Righetti and on Roll Call carried all seven voting aye.

REQUESTS FOR AGENDA ITEMS:

Ms. Schaefer requested a discussion on the land use ordinance, specifically limiting impervious surfaces such as parking lots.

PUBLIC COMMENT:

Frank D'Amore, Sr., 40 Willow Avenue, North Plainfield, voiced his displeasure with the deterioration of the Villa Maria property, specifically the dilapidated buildings, calling to question why the owners had not been held accountable.

Responding to Mr. D'Amore's inquiry about the new parking lot at Somerset Street and Pearl Street, Mr. Hollod confirmed that it would open after light installation by PSE&G.

Thalia Saloukas, 280 Watchung Avenue, North Plainfield, voiced her disappointment with the passage of Ordinance No. 17-01, noting the lack of consideration for the taxpayers and constituents.

COMMENTS BY MAYOR, ADMINISTRATOR AND COUNCIL MEMBERS:

Commenting on behalf of Mayor Giordano, Mr. Hollod noted the success of the Easter Egg Hunt. He announced that the annual Fishing Derby would be held April 29 and Clean Communities Day would be held May 6.

Mr. Merrill reported that the 7-11 had donated \$711 to the Girls on the Run program.

Addressing the public comments on Ordinance No. 17-01, Mr. Singleterry explained that the ordinance allows for the option of office space for doctors, dentists, and lawyers, not commercial retail space. He further explained that the Economic Development Committee made the recommendation in 2007 and it was included in the Master Plan update in 2014.

Mr. Stabile cited the Vornado property as a prime example of what had been done to bring back a commercial property. He commented on the New Jersey State League of Municipalities magazine which included an article about "The Lights of Washington Park" by Ken Lombardo.

Motion to adjourn by Ms. Miller, seconded by Mr. Stabile and carried unanimously.
