MINUTES of the Regular Meeting of the Council of the Borough of North Plainfield held on Monday, **June 26, 2017** at 8:07 p.m. at the North Plainfield Borough Council Chambers, 263 Somerset Street, North Plainfield, New Jersey.

Mr. Phoenix read the following notice:

The Council President read the following Notice of Compliance:

Courier News on December 1, 2016 and by posting a copy of this notice on the bulletin boards in the Municipal Building and Memorial Library reserved for such purpose."

The Clerk had submitted copies of the minutes of the Agenda Conference, Regular Meeting, and Executive Session of June 12, 2017.

Council President La Ronde called for a Roll Call on the minutes of the Agenda Conference, Regular Meeting, and Executive Session of June 12, 2017: All in favor.

HEARING:

ORDINANCE NO. 17-11 AN ORDINANCE AMENDING, REVISING AND SUPPLEMENTING CERTAIN SECTIONS OF THE NORTH PLAINFIELD BOROUGH CODE BY ADDING A SECTION TO THE NORTH PLAINFIELD BOROUGH CODE AS TO CHAPTER 3, "POLICE REGULATIONS," BANNING THE SALE OF DOGS AND CATS

The Clerk read the Ordinance by its title.

PUBLIC COMMENT:

Jonathan DuGrey, Owner, Shake-A-Paw Pet Stores, 14 US Route 22, Green Brook, NJ, said that he had never been cited by the municipal health department, and commented that New Jersey pet stores are required to abide by the laws enforced by local health departments and the NJ Division of Consumer Affairs. Regarding shelter dogs, they are only examined once yearly. He concluded that pet shops are a great American business, and invited all to visit his shop.

Janice Fisher, 58 Morris Avenue, Manasquan, NJ, said that although pet stores often pass their inspections, that they are known to buy from prohibited breeders. Seventy-Two breeder violations, she alleged, were racked up from last year, that the reports would make you cringe, and pet shops should switch to "rescue" animals.

Larry Cohen, 24 McLendon Place, Fanwood, NJ, found it disturbing to hear that people involved with caring for animals were creating class warfare, which was verified by research he had personally done. He decried puppy mills where animals were bred for profit. Missouri, he said, is a hotbed of puppy mills, and a breeder could bury up to 1,000 pounds of dead animals per acre per year. The USDA, he affirmed, has appalling standards, and the Animal Welfare Act suffers from lax regulations.

Elizabeth Dente, 182 Rockview Avenue, advised that she sits on the Borough Office of Emergency Management, and that she had tried to track down information. She offered paperwork indicating that, in the 07060 region, at least 1,363 dogs are available, and the vast majority have local origins. She criticized the on-line lists from Furrylicious and Shake-A-Paw as being misleading, that they were offering dogs originating from puppy mill states and that it only costs \$10.00 to gain USDA recognition.

Jack Morton, Shake-A-Paw, remarked that this was not a legal proceeding, and that lies were being given without recourse. He recalled being in the animal business for 26 years in a variety of roles, and that they could only buy from the best of breeders. He affirmed that he was the stakeholder with a business

located just one mile away, and further explained that the aforementioned 1,000-pound limit also applied to livestock.

Bonita (last name indistinct), 50 Rockview Avenue, North Plainfield, said that she cares for others' dogs, that people had had horrendous experiences with dogs from Shake-A-Paw and that she had seen disgusting things.

Brian Hackett, Director, NJ State Humane Society, advised that his is the largest, most respected agency of its kind in the world, and criticized Mr. Morton's comments. Mr. Hackett reported that 104 similar ordinances to this one had been adopted by municipalities throughout the state of New Jersey without citing a specific business. He concluded that the curtain is closing on pet shops that source their animals from puppy mills.

Joan Rogauskas, 128 Sandford Avenue, North Plainfield, said that she had never bought a pet from a pet store, and had always adopted. She commented on the abundance of stray cats, saying that people need to be encouraged to adopt. Although she admitted to being a "crazy cat lady," she expressed her support of the dog people.

Theresa Vaccaro, 260 Corbett Place, North Plainfield, supported the ordinance.

Kimberly Bowers, 418 Catalpa Avenue, North Plainfield, reported on shutting down many pet stores in Atlantic County, where eight out of ten puppies wound up in shelters.

Maria Castro, 381 Watchung Avenue, North Plainfield, said that she had once gone to Shake-A-Paw and was horrified. A friend had fallen in love with a puppy at the shop. They researched the breeder and determined that the puppy had come from a puppy mill breeder with violations. She concluded that puppy mill dogs develop problems as they age.

Motion to close public hearing by Mr. Merrill, seconded by Mr. Stabile and on voice vote carried all six in favor.

Ms. Schaefer presented the following Resolution and moved its adoption:

HEARING:

RENEWAL OF PLENARY RETAIL CONSUMPTION LICENSE NO. 1814-33-007-008 (DOMBAR LLC, d/b/a INTERNATIONAL CLUB & SPORTS BAR)

The Clerk read the above title.

Mr. Bernstein conducted the hearing, explaining that tonight's hearing had originated from a neighboring business owner's complaint, and opened the floor to comment.

Mr. Stephen A. Caputo, Esq. identified himself as representing DOMBAR LLC, while Mr. Phillip Rosenbach, Esq. advised that he was representing the owners of Somerset Square.

Henry M. Long, 880 Liberty Corner Road, Warren, identified himself as a principle of 815 Corporation, d/b/a Somerset Square.

Mr. Rosenbach stated that they opposed the renewal of DOMBAR's Plenary Retail Consumption License No. 1814-33-007-008, and that the International Club was having a detrimental effect on Somerset Square.

Mr. Long said that he and his father had been co-owners of Somerset Square since 1985. It houses several tenants, the main one being Quick Chek, which is open around the clock. Other tenants keeping night hours until 11:00 p.m. are the Chinese restaurant and La Strada Pizzeria, while others stay open until 10:00 p.m. The pass-through driveway is the only separation between the International Club and Somerset Square. He assured that he had no daytime difficulties with the Club, but that when everyone exits at 2:00 a.m., there are a variety of problems that often continue until 3:00 a.m. Mr. Long acknowledged that he had assembled surveillance videos and delivered them to the Clerk's Office which were shared with the Governing Body and administration. He added that he and his father who is now hospitalized had had some nasty experiences with Club patrons, and that a vehicle on his premises had been damaged.

Mr. Rosenbach shared a letter received from Quick Chek's corporate offices, and Mr. Long interjected that although the letter was pretty passive in nature, problems had peaked in 2014 and 2016. Mr. Long noted lewdness with patrons urinating on the night manager's vehicle and the corner of the Quick Chek itself, and there had been a disagreeable encounter between him and Mr. Dominguez over another matter.

Mr. Bernstein called for the interchange to focus on actions derived from statements appearing in a transcript of the above encounter. He added that actions depicted were neither grounds for renewal nor denial.

Mr. Long commented that much after-hours traffic in his lot revolved around taxis picking up bar patrons, and it wasn't clear from where. Mr. Caputo asked Mr. Long to characterize his tenants (retailers) at Somerset Square. He confirmed that they try to maintain a high level of local tenants and to specifically avoid tenants that would cause trouble. He added that although the Quick Chek is a desirable, responsible tenant, that their 24-hour operation encouraged increased late-night traffic. Mr. Bernstein reminded that the hearing was dedicated to the licensed premises.

Mr. Long explained the 90-minute audio recording he had provided between himself and Mr. Dominguez. It had been made at the laundromat. He characterized the conversation as threatening. Mr. Caputo advised of a police report from the Borough's Officer Dzibella, who had investigated the vandalism of one of Mr. Long's surveillance cameras. The attorney noted that there was no means of identifying people in the parking lot area as being from the International Club or another establishment. Mr. Long commented on bottles being thrown from vehicles operated by International Club patrons.

RECESS:

Mr. Bernstein called for a recess at 9:59 p.m., with the hearing being reconvened at 10:18 p.m., all Council Members again marked present that were present at the initial roll call.

Mr. Bernstein obtained reassurance from Mr. Caputo that his client would not seek to close down or prevent the license renewal of the International Club between now and 10 July 2017. The Borough Attorney advised that Mr. Caputo now had at least three witnesses for tonight that might not be available on 10 July. Mr. Bernstein commented that about 18 employees of the International Club were available to testify tonight including eight members of the security staff. Both Messrs. Caputo and Rosenbach agreed that there would be no action until the Council's scheduled July 10th Regular Meeting.

Taisha McCall, Head Bartender, International Club, under questioning from Mr. Rosenbach, said that her patrons were civilized, and that the club's patrons typically feel safe and secure. Patrons that have exited the club, she said, are monitored by security, and watched for possible fights and disagreements which they endeavor to quell.

Yurkas Taranta Peralta, another club employee, affirmed that it is the cleanest bar in the Plainfield/North Plainfield area, and that there were huge fights at other bars in the region. Any altercations at the International Club are handled professionally. If there are any potential disagreements, she said, the patrons are escorted out of the premises.

Steven Jaran, 42 Steiner Place, spoke on his experience as a neighbor, living behind the Somerset Square laundromat for sixteen years. He noted improvements instituted by the club, having endeavored to clean up and secure a vacant lot that had been a nuisance over the years. A security camera had initially been installed too near his teenage daughter's bedroom window. Its coverage had been adjusted on request, and he was satisfied, adding that his three dogs were barking less; but, he added that his property still experiences litter from the Quick Chek.

Replying to Mr. Bernstein, Mr. Jaran confirmed that he has his own security cameras on the front of his house, and that he had helped Somerset County to prosecute crimes.

Mr. Bernstein requested a motion to adjourn the hearing until the Council's scheduled July 10th Regular Meeting.

Mr. Stabile so moved, seconded by Ms. Miller and on voice vote carried unanimously

Mr. Bernstein added that the evening's scheduled executive session would not be held.
