1. **Award of Bid for Memorial Library Renovations and Improvements** – D.E.H. Mr. Hollod reported that the bids remain under review and action would be taken at the next regularly scheduled council meeting.

2. Award of Bid for Norwood Avenue Roadway Improvements – D.E.H. Mr. Hollod explained that this resolution authorizes the award of the bid and contract for the Norwood Avenue Roadway Improvements project to the lowest responsible bidder, Cifelli & Son General Contracting, Inc.

3. **Rejection of Bids for Public Works Fueling Station** – D.E.H. Mr. Hollod advised that this resolution authorizes the rejection of bids received for the Public Works Fueling Station project as all bid amounts were approximately thirty-three percent over budget.

4. **Revisions to Parking Restrictions on Wilson Avenue and Chestnut Street** – D.E.H. Mr. Hollod explained that this ordinance restricts parking during school hours, specifically from 7:00 a.m. to 3:00 p.m.

REPORTS OF BOARDS, COMMITTEES, COMMISSIONS:

Mr. Merrill reported on the success of the Parks and Recreation Committee's summer camp program. He further reported that more than 400 children had signed up to play soccer and approximately 70 children and 15 adults had signed up for archery.

Council President La Ronde reported on the town-wide garage sale scheduled for September 16 and 17.

Motion to adjourn by Ms. Miller, seconded by Mr. Merrill and carried unanimously.
