**RESOLUTION NO. 09-23-19-01** REMEMBERING COUNCILMAN FRANK RIGHETTI FOR HIS YEARS OF SELFLESS SERVICE TO THE BOROUGH OF NORTH PLAINFIELD

WHEREAS, FRANK RIGHETTI, served in a variety of capacities in the municipal government of the Borough of North Plainfield since 1995; and

WHEREAS, FRANK RIGHETTI was initially a member of the North Plainfield Planning Board beginning 1995. He was also a functional historian of the Borough of North Plainfield; and

WHEREAS, FRANK RIGHETTI also served on the Property Maintenance Committee where he also served a term as Chairman; and

WHEREAS, FRANK RIGHETTI was appointed by the Borough Council in September 2000 to fill the vacancy for the remainder of an unexpired term, and was subsequently re-elected to multiple terms on Council by the voters; and

WHEREAS, COUNCILMAN RIGHETTI, in his time on the Governing Body continued serving the Borough in multiple capacities — on the Sewer Usage Charge Board of Appeals; with multi-year terms on the Green Brook Flood Control Commission; on the Environmental Commission; the Somerset County Solid Waste Advisory Committee; on the Parking Authority; on the Krausche Field Turf Committee and on the body convened for the expansion/renovation of the North Plainfield Borough Hall and on the Local Assistance Board; and

WHEREAS, throughout his distinguished years in service to the Borough of North Plainfield, FRANK remained a steadfast fount of information, significant Borough history and guiding source of intuitive good sense.

NOW, THEREFORE, BE IT RESOLVED that the Borough Council of North Plainfield does hereby honor the memory of our friend COUNCILMAN FRANK RIGHETTI for his selfless dedication to the Borough and its residents in countless capacities over the years of service to this, his "hometown." On behalf of all the people of this community, this Governing Body does spread upon its permanent records the deepest of sympathies to his wife, JoAnne, their children and grandchildren for the gift of Frank and his many years of dedicated service to the Borough of North Plainfield. WHEREAS, the Municipal Land Use Law (N.J.S.A. 40:55D-53) permits the Borough of North Plainfield to accept certain improvements and to release performance guarantees, bonds and/or escrow posted by developers when said improvements have been certified as complete by the Borough Engineer; and,

WHEREAS, North Plainfield UE, LLC, the developer of Petco, with a main business address of 1200 U.S. Route 22 East, North Plainfield, New Jersey 07060, has deposited with the Borough of North Plainfield a performance guarantee, bonds and escrow, which were to guarantee the completion of certain improvements on the premises located at 1200 U.S. Route 22 East, North Plainfield, New Jersey 07060, also known as Block 203.01, Lot 1, as show on the Tax Map of the Borough of North Plainfield; and,

Testa, P.E., C.M.E., C.P.W.M. and the full release of the performance guarantee, bonds and escrow for North Plainfield UE, LLC are hereby released, canceled and/or discharged.

# COMMENTS BY MAYOR, ADMINISTRATOR AND COUNCIL MEMBERS:

Mayor Giordano commented on the violation at 22 Mountain Avenue which had been addressed by Property Maintenance. There seems to be an issue with a tenant and Code Enforcement Office will follow up, he assured. Commenting on Mr. Righetti, he noted that Frank was a gentleman who always did as asked and would be missed. He reported on the success of the Fall Clean Community Day which saw over two hundred volunteers. The first ever North Plainfield Fall Festival will be held Saturday, September 28. Please visit the Borough's website for further details regarding all events.

Mr. Hollod thanked the Righetti family, recalling what a pleasure it was when Frank would visit Borough Hall. He announced that the preliminary draft of the Best Practices questionnaire is complete and may be added to the second meeting in October.

Mr. Merrill announced that the North Plainfield Education Association has invited the council members to a meet and greet at Arooga's scheduled for September 24 from 3:00 p.m. to 7:00 p.m. Rich Norz and his wife were grateful for the success of the Farmers Market here in town, he reported, continuing that they were impressed with the welcoming attitude of their North Plainfield customers. He assured that the Norz family would be interested in participating in another series of Thursday markets next year.

Ms. Miller fondly recalled her time spent sitting beside Frank during meetings, noting that he would be sorely missed.

Ms. Corzo reported on the recent Planning Board discussion of a proposed subdivision of 177 Maple Avenue; the matter was tabled.

Ms. Schaefer fondly recalled the good times spent sitting beside Frank at meetings and thanked his family members for sharing him.

Mr. La Ronde reported on the success of the Fall Clean Community Day as the volunteers exhibited fabulous energy. He thanked Ms. Miller in the Mayor's office for her tireless efforts with the event. He asked that residents consider making donations to offset the shortages at the food bank. Commenting on Frank, the Councilman recalled missing the element of surprise as you never knew what would come out of his mouth. We enjoyed his humor and he will be sorely missed in the community, he concluded.

Mr. Singleterry also recalled having the privilege of sitting beside Frank during Council meetings and experiencing his humor and wit. He was elected to five Council terms and contributed so much to the Borough, he remarked.

Council President Stabile touched on the topic of 22 Mountain Avenue. Advising that he had personally walked by the property, he agreed with Mr. D'Amore about the misplaced trash cans, but took exception to the idea that certain residents had received "preferential treatment" by the code enforcement office. The Council President then reported on his attendance at the Grand Opening of Studio 15 Productions in Vitelli Village. The business owner wished to acknowledge the ease of working with the various Borough officials throughout the process. Mr. Stabile then spoke of learning a tremendous amount while seated next to Frank over the years. Frank always provided moments of levity and comedic relief, which will be dearly missed.

Motion to adjourn by Mr. La Ronde, seconded by Ms. Miller and on voice vote carried unanimously.
