The Pledge of Allegiance to the Flag was led by Council President Stabile.

Council President Stabile requested a moment of silence for the men and women serving in our Armed Forces as well as those in the medical community and the first responders for their efforts during the Covid-19 pandemic.

The Council President read the following Notice of Compliance:

"This meeting is being held in compliance with N.J.S.A. 10:4-6 et seq. Adequate notice of this meeting was provided by transmitting notice to the official newspapers of the Borough, The Courier News, WKMB Radio, WJLP-TV, the Alternative Press and also to the Star Ledger on April 23, 2020 and by posting a copy of this notice on the bulletin boards in the Municipal Building and the Memorial Library reserved for such purpose."

Mayor Giordano read the Mayor's Call of Meeting:

I, Michael Giordano, Jr., Mayor of the Borough of North Plainfield, do hereby call a Special Meeting of the North Plainfield Borough Council for Monday, April 27, 2020 at 3:00 PM. Such Meeting is expected to be conducted by telephone/videoconference due to the current COVID-19 Virus Public Health Emergency declared by Governor Philip Murphy which requires social distancing measures that would not be achievable in the customary location in the Council Chambers at North Plainfield Borough Hall in addition to P.L. 2020, c.11. The Borough Clerk is charged with providing proper notice of the Meeting to all applicable parties, to setting up the technical parameters to training the participants in the proper use/procedures of the telephone/videoconferencing methodology and by conducting the Meeting in accordance with all governing statutes, including the allowance for public participation. The purpose of this Special Council Meeting is to hold a Public Hearing and vote on Ordinance No. 20-02 (Cap Bank Ordinance), hold a Public Hearing and possibly vote on the adoption of the 2020 Municipal Budget, vote to approve payments of bills, vote to adopt a temporary budget, vote to endorse an application for a State Library Grant, vote to approve professional services proposals, vote to approve an employee separation agreement, vote to authorize cancellation of taxes, vote to authorize issuance of Estimated Tax Bills, vote to authorize the Mayor and Clerk to pay bills and conduct any and all other such business during the Public Health Emergency and when the Council is not in session, and finally, to conduct any other such matters of business as may be necessary and required to be approved at an otherwise regularly scheduled Council Meeting.

The Clerk read the Ordinance by its title.

PUBLIC COMMENT: None.

Motion to close public comment by Mr. La Ronde, seconded by Ms. Miller and on Roll Call carried all six voting aye.

Ms. Schaefer presented the following Resolution and moved its adoption:

RESOLUTION NO. 04-27-20-01 BE IT RESOLVED by the Council of the Borough of North Plainfield that an ordinance numbered 20-02 be adopted and advertised as required by statute.

Authorization for Self-Examination of 2020 Municipal Budget

Mr. Bernstein requested that item "*l*" be removed from the Consent Agenda and considered separately at this portion of the meeting.

Mr. La Ronde presented the following Resolution and moved its adoption:

RESOLUTION NO. 04-27-20-041 AUTHORIZING SELF-EXAMINATION OF BUDGET

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Borough of North Plainfield has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the local government meets the necessary conditions to participate in the program for the 2020 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the Borough of North Plainfield that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:

- a. Payment of interest and debt redemption charges
- b. Deferred charges and statutory expenditures
- c. Cash deficit of preceding year
- d. Reserve for uncollected taxes
- e. Other reserves and non-disbursement items
- f. Any inclusions of amounts required for school purposes.
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
 - 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated,
 - b. Items of appropriation are properly set forth
 - c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
 - 6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.

Seconded by Ms. Corzo and on Roll Call carried all six voting aye.

PUBLIC COMMENT:

Francine Gargano, 57 Willow Avenue, North Plainfield, requested consideration for those residents hurt financially during the pandemic as they may not be able to pay their property taxes. Addressing Ms. Gargano's concerns, Mr. Hollod assured that the Borough would look to use a portion of its surplus as well as those funds allocated for snow removal.

Whereas, the Borough of North Plainfield does accept funding of \$90,000 with a match of \$425,720 for an approximate project total cost of \$515,720 for a project under the State of New Jersey Safe and Secure Neighborhoods Grant Program, Subaward number: P-20-1814, with a subaward award period of March 1, 2020 to February 28, 2021, and

- 3. The Division of Criminal Justice shall be responsible for the receipt and review of the application for said funds.
- 4. The Division of Criminal Justice shall initiate allocations to each applicant as authorized.

RESOLUTION NO. 04-27-20-04c RESOLUTION REQUESTING THE NEW JERSEY DEPARTMENT OF TRANSPORTATION (NJ DOT) TO ISSUE A TRAFFIC REGULATION ORDER FOR THE ESTABLISHMENT OF CERTAIN BUS STOPS ALONG ROUTE U.S. 22 IN THE BOROUGH OF NORTH PLAINFIELD.

WHEREAS, pursuant to <u>N.J.S.A.</u> 39:4-8.4c, the New Jersey Department of Transportation ("NJDOT") may immediately issue a Traffic Regulation Order in response to a resolution of support from the governing body of a municipality if the Traffic Regulation Order pertains exclusively to a public highway or transportation system located within the boundaries of that municipality; and,

WHEREAS, the Borough of North Plainfield ("Borough") wishes to request that the NJDOT issue a Traffic Regulation Order for the establishment of certain bus stops along Route U.S. 22 in the Borough.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey as follows:

1. The Borough requests that the NJDOT issue a Traffic Regulation Order for the establishment of bus stops along Route U.S. 22 as follows:

Along Route U.S. 22, eastbound, on the southerly side at:

West End Avenue – (near side) (NJ Transit ID #28335)

Beginning at the westerly curb line of West End Avenue and extending one hundred and five (105) feet westerly therefrom.

Along Route U. S. 22, westbound, on the northerly side at:

West End Avenue – (near side) (NJ Transit ID #30917)

Beginning at the easterly curb line of West End Avenue and extending one hundred and five (105) feet easterly therefrom.

2. The Borough concurs that any approved bus stop locations or traffic regulations in conflict with or inconsistent with the provisions of this Resolution be rescinded upon approval of the Traffic Regulation Order.

RESOLUTION NO. 04-27-20-04m RESOLUTION OF THE BOROUGH COUNCIL IN SUPPORT OF A MOBILE COVID-19 TESTING FACILITY WITHIN SOMERSET COUNTY

WHEREAS, the Borough of North Plainfield, in the County of Somerset, New Jersey (the "Borough"), a public body corporate and politic of the State of New Jersey (the "State"), is facing a health crisis related to the spread and treatment of the COVID-19 virus, and

WHEREAS, in order to assist in the combat of the spread of the COVID-19 virus the performance of tests to help identify infected individuals is necessary, and

WHEREAS, several other counties within the State have established mobile drive thru testing sites for the benefit of their residents, and

WHEREAS, the County of Somerset in conjunction with the County of Hunterdon desires to establish and operate a mobile testing site for their residents, and

WHEREAS, the County of Somerset has identified Raritan Valley Community College as a suitable location for the mobile testing facility; and

WHEREAS, the County of Somerset and the County of Hunterdon have agreed to share the costs and responsibility for the staffing and operation of the facility; and

WHEREAS, in order to establish and operate the mobile testing facility certain equipment including personal protective equipment and testing kits are necessary for the operation of the facility; and

WHEREAS, the State of New Jersey in conjunction with the United States of America possesses the authority and ability to provide the necessary equipment needed for the establishment and operation of the mobile testing facility; and

WHEREAS, the Borough Council requests that the State provide the needed resources.
