WHEREAS, Councilman Douglas Singleterry resigned from the North Plainfield Borough Council effective the close of business, Thursday, December 31, 2020 in order to become a Somerset County Freeholder (Commissioner) on January 1, 2021, thereby causing a Council vacancy;

WHEREAS, pursuant to N.J.S.A. 40A:16-3, N.J.S.A. 40A:16-5 and N.J.S.A. 40A:16-11, the North Plainfield Democratic Committee has provided the requisite number of names required for the Borough Council to consider for filling the Council vacancy until the next General Election when a candidate will be elected and qualified to serve as a Council member for the Borough of North Plainfield till December 31, 2022.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey, that the Borough Council selects Suezette Given to serve as a Council Member on the North Plainfield Borough Council until the next General Election (November 2, 2021) at which time a candidate will be elected by the voting public of the Borough, and until the incoming candidate's election is certified and qualified in accordance with law, who will then serve the remainder of the unexpired term till December 31, 2022. This will fill the unexpired term of Mr. Singleterry as per above.

RESOLUTION NO. 01-11-21-03a RESOLUTION OF THE BOROUGH COUNCIL AUTHORIZING THE MAYOR AND BOROUGH CLERK TO EXECUTE A SHARED SERVICES AGREEMENT WITH THE SOMERSET COUNTY BOARD OF HEALTH TO PROVIDE PUBLIC HEALTH SERVICES TO THE BOROUGH OF NORTH PLAINFIELD

WHEREAS, the Borough of North Plainfield is in need of public health services; and,

WHEREAS, the Borough of North Plainfield desires to enter into a Shared Services Agreement with the Somerset County Board of Health in accordance with the Uniform Shared Services Act, N.J.S.A. 40A:65-1 *et seq.* to provide such public health services to the Borough.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Mayor and the Borough Clerk are hereby authorized to execute a shared services agreement with the Somerset County Board of Health for the provision of public health services to the Borough for a term not to exceed five (5) years, which shall be renewable annually commencing on January 1, 2021 and terminating on December 31, 2025. A copy of such shared services agreement is annexed hereto and incorporated herein and is on file in the Office of the Borough Clerk.

RESOLUTION NO. 01-11-21-03b RESOLUTION OF THE BOROUGH COUNCIL AUTHORIZING THE MAYOR AND BOROUGH CLERK TO EXECUTE AN AGREEMENT WITH RICH TREE SERVICE, INC. FOR THE MAINTENANCE AND REMOVAL OF TREES THROUGHOUT THE BOROUGH OF NORTH PLAINFIELD

WHEREAS, the Borough of North Plainfield is in need of certain services to maintain and remove trees throughout the Borough for the calendar year 2021 and Alternate A for calendar year 2022 (hereinafter referred to as the "Project"); and,

WHEREAS, the Borough of North Plainfield solicited bids for the Project and two (2) bids were received, which are as follows:

WHEREAS, Director of Law/Borough Attorney Eric M. Bernstein, Esq. and the offices of Eric M. Bernstein & Associates, LLC have reviewed the bid submissions and recommend the award of the bid and contract for the Project to the lowest responsible bidder, Rich Tree Service Inc., whose main offices are located at 325 Bergen Street, South Plainfield, New Jersey 07080 (hereinafter referred to as the "Contractor") as there are no material defects with the bid proposal; and,

WHEREAS, the Borough of North Plainfield is desirous of obtaining the services of the Contractor to perform all those services contemplated in the Borough's bid documents and the bid proposal submitted by the Contractor; and,

WHEREAS, the Borough of North Plainfield finds that the Contractor is the lowest responsible bidder for the Project, both the Base Bid and Alternate Bid A, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Council hereby awards the following Bid and Contract:

Project: Tree Maintenance and Removal

Successful Bidder: Rich Tree Service, Inc.

Total Bid: In the Amount of One Hundred Ninety-Five Dollars and Zero Cents Per

Hour (\$195.00).

Term: Calendar Years 2021 and 2022.

BE IT FURTHER RESOLVED that the Borough Council, at the recommendation of the Director of Law, accepts Alternate Bid A for the services in calendar year 2022.

BE IT FURTHER RESOLVED that the Borough Council hereby authorizes the Mayor and the Borough Clerk to sign and/or execute the contract and all necessary documents to engage the construction services of Rich Tree Service, Inc. for the Project; and,

BE IT FURTHER RESOLVED that the award of this contract shall be subject to the certification of the Borough's Chief Financial Officer as to the availability of funds for payment for same; and,

BE IT FURTHER RESOLVED that the award and the contract and its performance shall be consistent with all applicable laws, the Borough's bid documents and the bid proposal of Rich Tree Service, Inc. for the Project known as the Tree Maintenance and Removal Services.

RESOLUTION NO. 01-11-21-03c RESOLUTION OF THE BOROUGH OF NORTH PLAINFIELD AUTHORIZING THE ADOPTION OF PROCEDURES AND REQUIREMENTS FOR PUBLIC COMMENT AT REMOTE PUBLIC MEETINGS

WHEREAS, pursuant to Governor Phil Murphy's Executive Order Number 103 dated March 9, 2020, Governor Phil Murphy declared a Public Health Emergency and a State of Emergency in New Jersey; and,

WHEREAS, on March 20, 2020, <u>P.L.</u> 2020, Chapter 11 amended the Open Public Meetings Act to allow local public bodies, such as the North Plainfield Borough Council, to conduct Remote Public Meetings by use of electronic communications technology during a period declared as a Public Health Emergency or a State of Emergency; and,

WHEREAS, the State of New Jersey Department of Community Affairs issued regulations requiring local public bodies to adopt standard procedures and requirements for public comment made during Remote Public Meetings and for public comment submitted in writing to such meeting; and,

WHEREAS, in accordance with <u>N.J.A.C.</u> 5:39-1.4(h), the Borough of North Plainfield desires to adopt standard procedures and requirements for public comment made during Remote Public Meetings and for public comment submitted in writing to such meetings.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough of North Plainfield Council hereby adopts the following procedures and requirements for public comment made during Remote Public Meetings:

1. Public comments which are neither obscene, defamatory and/or abusive will be accepted that are submitted in written form or via electronic mail received at the office of the Borough

Clerk of the Borough of North Plainfield (hereinafter the "Borough") at least two (2) business days prior to the date of the meeting. Public comments submitted through electronic mail or written letter before the remote public meeting shall be read aloud and addressed during the remote public meeting in a manner audible to all meeting participants, including public participants. Any written or electronic submissions which contain obscene, defamatory and/or abusive language will not be read aloud as same shall be considered disruptive to the Borough Council meeting.

- 2. At the end of the regular business session of a Remote Public Meeting, a reasonable period of time will be provided for public comment, consistent with the Borough's prior and current rules governing the public portion of its non-remote meetings. In addition to the written submissions being read aloud during the public portion, members of the public attending the Remote Public Meeting will be able to submit comments by raising their virtual hand and/or its equivalent function in the Zoom/remote meeting application or by typing in their information in the comment section of the remote meeting application. The moderator of the Zoom Meeting/remote meeting application and/or the Borough Clerk will recognize those members of the public that wish to submit a comment and, if more than one, will establish a queue for those wishing to comment. The Council President will recognize, in order, each member of the public that desires to provide public comment. When recognized, the member of the public shall identify themselves by name, address and, if applicable, the group or organization that they represent.
- 3. Members of the public participating in a Remote Public Meeting shall conduct themselves with decorum, shall not use abusive, defamatory, or obscene language and any comments made shall be concise and to the point. The Council President, in his/her discretion, may interrupt, warn, or mute the individual's ability to speak if their conduct/comment is abusive, defamatory, obscene, or overly long.

RESOLUTION NO. 01-11-21-03d A RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF NORTH PLAINFIELD ACCEPTING A DONATION OF OFFICE EQUIPMENT FROM TRIDENT FURNITURE SERVICES FOR THE USE OF THE NORTH PLAINFIELD POLICE DEPARTMENT

WHEREAS, the North Plainfield Police Department has an ongoing need for office equipment; and,
