WHEREAS, the Borough of North Plainfield is in need of certain sanitary sewer replacement improvements as it relates to the West End Avenue Sanitary Sewer Replacement Project (hereinafter referred to as the “Project”); and,

WHEREAS, the Borough of North Plainfield solicited bids for the Project and received seven (7) bids, the three (3) lowest of which are as follows:

WHEREAS, Director of Law/Borough Attorney Eric M. Bernstein, Esq. and the offices of Eric M. Bernstein & Associates, LLC, as well as Mott MacDonald, LLC, the Borough’s Engineer on the Project, have reviewed the bid submissions and recommend the award of the bid and contract for the Project to the lowest responsive and responsible bidder, CMS Construction, Inc., whose main offices are located at 521 North Avenue, Plainfield, NJ 07060 (hereinafter referred to as the “Contractor”), as there are no material defects with the bid proposal; and,

WHEREAS, the Borough of North Plainfield is desirous of obtaining the services of the Contractor to perform all those services contemplated in the Borough’s bid documents and the bid proposal submitted by the Contractor; and,

WHEREAS, the Borough of North Plainfield is in need of certain improvements to roadways throughout the Borough as part of the 2021 Capital Road Improvement Program; and,

WHEREAS, the Borough of North Plainfield has received a proposal from Grotto Engineering Associates, LLC to provide professional services, including, but not limited to, preparation of public bid design documents for said road improvements, as well as providing bid support and construction administration/observation services related to the project; and,

WHEREAS, Grotto Engineering Associates, LLC has recommended that the following streets be included in the Borough's 2021 Capital Road Improvement Program in the following order:

1. Berry Hill Court
2. Holly Drive
3. Jeffries Place/Farragut Road
4. Gavin Place
5. Glen Court
6. Glenside Place
7. Howard Street
8. Louise Ave
9. Mercer Ave
10. Mountainview Drive
11. Stahls Way
12. Steiner Place (Linden to Gavin)
13. Steiner Place (Howard to Dupont)
14. Summit Ave (Westervelt to Delacy)
15. Taft Ave

This list is subject to change based upon available funding and road conditions; and,

WHEREAS, the scope of the 2021 Capital Road Improvements is anticipated to incorporate approximately Eleven Thousand Seven Hundred (11,700) linear feet (2.21 miles) of

roadway resurfacing at an estimated total project cost of Eight Hundred Forty Thousand (\$840,000.00) Dollars; and,

WHEREAS, Grotto Engineering Associates, LLC will obtain field data in order to determine that the physical features of the roadways will be gathered (as required) to develop location mapping and unit price quantities for the roadway improvements. The Borough's tax maps will be used, as needed, to develop any base mapping needed and to assist in establishing existing features such as pavement limits, driveways, and utilities, etc., in order to ensure that the proposed improvements are accurately designed. Field mapping data information collected for base mapping will be compiled using AutoCAD. The production of these design documents will not exceed a total amount of Forty Seven Thousand (\$47,000.00) Dollars; and,

WHEREAS, following the completion of the bid documents, Grotto Engineering Associates, LLC will coordinate bid dates with the Borough and will provide assistance through the entire bidding process. Bid Packages will be sold by Grotto from their Cranford, New Jersey Office location. Following the receipt of bid proposals, Grotto Engineering will review all bids submitted and provide a recommendation of award to the Borough; and,

WHEREAS, following award of contract by the Borough, Grotto Engineering Associates, LLC will prepare all contract documents and conduct a pre-construction meeting with the successful contractor, all appropriate Borough personnel and any affected utility companies. During the course of construction, Grotto Associates, LLC will further provide construction observation and administrative services to ensure that the contractor is performing all construction in full accordance with the contract documents; and,

WHEREAS, Grotto Engineering Associates, LLC will also review and approve all payment applications submitted by the contractor before they are presented to the Borough for payment. As the project approaches completion, Grotto Engineering Associates, LLC will provide the contractor with a detailed punch list of any and all items requiring repair and/or correction. Grotto Engineering Associates, LLC will also prepare the final payment and closeout documents, and,

WHEREAS, the aforementioned services related to Bid Support, Contract Administration and Inspection will not exceed an additional amount of Forty Two Thousand (\$42,000.00) Dollars; and,
