WHEREAS, the Borough of North Plainfield (hereinafter referred to as the “Borough”) is in need of certain road improvements for the 2021 NJDOT Municipal Aid Program – Brook Avenue Improvements (hereinafter referred to as the “Project”); and,

WHEREAS, the Borough received an NJDOT Local Aid Grant in the amount of Three Hundred Ten Thousand Dollars (\$310,000.00) to perform the work; and,

WHEREAS, Director of Law/Borough Attorney Eric M. Bernstein, Esquire and the offices of Eric M.
