Bernstein & Associates, L.L.C., as well as CTS Group Architecture & Planning, P.A., the Borough's Architect on the Project, recommended rejection of both bids because both bids exceeded the Borough Architect's estimates by significantly higher amounts; and,

WHEREAS, the Borough of North Plainfield therefore rejected both bids in Resolution 10-24-22-2(a); and,

WHEREAS, pursuant to *N.J.S.A.* 40A:11-5(3)(b), bids were advertised pursuant to section 4 of <u>P.L.</u>1971, <u>c.</u> 198 (<u>C.40A:11-4</u>) on two (2) or more occasions and the governing body rejected the bids because it determined that no bids were initially received, and the bids which were finally received after reissuance of requests for bids were not reasonable as to price, on the basis of cost estimates prepared for or by the contracting agent prior to the advertising therefor; and,

WHEREAS, the Borough then made a reasonable effort to determine whether the same or equivalent goods or services, at a cost which is lower than the negotiated price, are available from an agency or authority of the United States, the State of New Jersey or of the county in which the contracting unit is located, or any municipality in close proximity to the contracting unit proceeded to negotiate a contract, and determined that such goods or services are not available through any such agency or authority; and,

WHEREAS, the Borough then notified each responsible bidder submitting bids on the second occasion of its intention to negotiate for a contract, and afforded each bidder a reasonable opportunity to negotiate; and,

WHEREAS, the Borough has negotiated with the lowest bidder, Salazar & Associates, Inc., for a lowest possible bid, and received a best-and-final bid of Two Hundred Eighty Thousand Dollars and No Cents (\$280,000.00) and the terms, conditions, restrictions, and specifications set forth in the negotiated contract are not substantially different from those which were the subject of competitive bidding pursuant to section 4 of <u>P.L.</u>1971, <u>c.</u> 198 (<u>C.40A:11-4</u>); and,

WHEREAS, the Borough negotiated a minor amendment or modification of the terms, conditions, restrictions, and specifications which were the subject of competitive bidding pursuant to section 4 of <u>P.L.</u>1971, <u>c.</u> 198 (<u>C.40A:11-4</u>), to the Contract Price in the amount of a reduction in the Contract Price in the amount of Two Hundred Dollars and No Cents (\$200.00), and the Governing Body may therefore award the contract because the negotiated price is lower than the lowest rejected bid price submitted on the second (2<sup>nd</sup>) occasion by a responsible bidder, is the lowest price offered by any responsible vendor, and is a reasonable price for goods or services.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the best-and-final bid received for the Project in the amount of Two Hundred Eighty Thousand Dollars and No Cents (\$280,000.00) submitted by Salazar &Associates, Inc., 2226 Morris Avenue, Union, New Jersey 07083 be and hereby is, accepted, the terms, conditions, restrictions, and specifications set forth in the negotiated contract being substantially similar to those which were the subject of competitive bidding pursuant to section 4 of P.L.1971, c. 198 (C.40A:11-4); because the negotiated price is lower than the lowest rejected bid price submitted on the second (2<sup>nd</sup>) occasion by a responsible bidder; is the lowest price offered by any responsible vendor; and, is a reasonable price for the contracted-for goods or services; and,

BE IT FURTHER RESOLVED that the Borough Council hereby authorizes the Mayor and the Borough Clerk to sign and/or execute any and all contracts to memorialize the proposal submitted by Salazar & Associates, Inc. to handle the bathroom renovations at the Vermuele Mansion, Vermeule Community Center and North Plainfield Memorial Library as per the issue discussed above; and,

BE IT FURTHER RESOLVED that the award of this proposal shall be subject to the certification of the Borough's Chief Financial Officer as to the availability of funds for payment for same.

#### **MAYOR'S MESSAGE:**

Mayor La Ronde read his State of the Borough address as follows:

Happy New Year and welcome to North Plainfield's first Borough Council meeting of the new year. I wish the Borough Council and everyone a very happy, healthy and prosperous 2023.

## <u>Police Department – Chief William Parenti</u>

In 2022, the Police Department received its sixth Re-Accreditation. This means the Police Department policies and methods of operation are subject to review by an independent team of accreditors to verify that the Department complies with current best practices. Our Police Department was the first in Somerset County to achieve this accreditation.

Post Covid-19, the Police Department has resumed our popular youth and community programs.

The Summer Teen Evening Program (STEP) opens a gym 2 nights per week to give our youth an opportunity to have a safe place to play basketball, soccer, or just interact with police officers.

The Police Youth Academy provides  $6^{th}$  through  $8^{th}$  grade students an opportunity to learn what police officers do.

Law Enforcement Against Drugs (LEAD) and (G.R.E.A.T), Gang Resistance Education And Training programs continue to be taught in the schools.

New for 2022 was Trunk or Treat, where officers handed out Halloween candy to the children at our Elementary Schools and the Police parking lot.

Also new was No Shave December. In exchange for not shaving, officers donated \$50.00 each to raise money to buy gifts for needy children. The presents were then delivered in person to each child.

Especially well received this year were our officers dressed as Santa and Mrs. Claus who went into each of the elementary schools and gave out candy canes.

We have received much praise for The School Resource Officer (SRO) program. Faculty, parents, and our students truly enjoy the positive interaction with police officers. The SRO program is committed to keeping the students and teachers safe.

We continued "Project Medicine Drop" and "Operation Take Back." These programs make it convenient for residents to dispose of their unwanted or expired prescription medications, thus reducing the chance that they end up on the street, in children's hands, or in the water supply. A secure collection box is located in the lobby of Borough Hall and is accessible 24 hours a day.

Our Good Morning program made hundreds of calls this year. This no-cost program is designed for shut-ins and senior citizens who live alone and have no one to look in on them. A member of the police department calls subscribing residents each day to ensure all is OK.

The Police Department Facebook page continues to grow. Social media allows us to communicate instantly with our citizens about important information like crime bulletins, road closures and general police information. Our Facebook page has assisted in solving countless crimes, from shoplifting to burglary.

## Fire/EMS Department – Chief William Eaton

In 2022 we responded to over 3,400 fire and emergency medical incidents and performed over 2,000 fire code inspections. Revenue from our emergency medical calls generated approximately \$440,000 for the Borough.

One of the training highlights for the fire department in 2022 was the continuation of a specialized training program that we have been jointly conducting with our neighboring fire departments. In

2021, through the FEMA Assistance to Firefighters Grant program, our department, along with the Plainfield and South Plainfield fire departments, were awarded approximately \$500,000 to be used for specialized technical rescue equipment and training. During 2022, we conducted another phase-in period of this project, participating in over 8 weeks of specialized training exercises. This included heavy rescue and large vehicle stabilizing techniques, as well as trench rescue operations.

In the fall of 2022, we were awarded two other grants – the first was the American Rescue Plan Firefighter Grant, with an award amount of \$54,000. We were among the top 5 recipients out of 300 municipalities for the funding amount received.

The second grant was a FEMA Assistance to Firefighters grant with an amount of \$48,000 for rope rescue equipment and training.

At the end of the year, we took delivery of a new replacement rescue ambulance, which was ordered back in 2021. This vehicle will be a welcome addition to our apparatus fleet and save on maintenance costs.

Lastly, during 2022, we established a shared services committee with Watchung for the purpose of exploring the joint purchase of a ladder truck. Our existing ladder truck is over 20 years old and due for replacement.

The cost of a new ladder truck is approximately \$2 million. We are submitting an application for a \$400,000 NJ SHARE grant. If this initiative is successful, we anticipate saving the Borough up to one million dollars on this much needed capital purchase.

## Public Works - David Testa, Director

This past year the Borough completed work on curb repairs, ADA sidewalk ramp improvements and the milling and resurfacing on sixteen roads in the Borough.

Additionally, we completed the traffic signal replacement at the Somerset Street intersection with Pearl Street and Craig Place. This project also involved drainage improvements in the intersection as well as the reconstruction of all ADA sidewalk ramps with stamped, tinted concrete.

The Borough started an NJDOT Grant Funded roadway, drainage, curb, sidewalk pedestrian safety improvement project on Brook Avenue between Sandford Avenue and Farragut Road. This project will be completed in the spring of 2023.

This coming year, we anticipate the completion of roadway and pedestrian safety improvements on Jackson Avenue, between Somerset Street and Sandford Avenue and also on Delacy Avenue.

These two projects are being funded in part by over \$750,000 in NJDOT Local Aid Grants which are supported by the state gasoline tax.

Also planned is the replacement of some sidewalk slabs in areas where Borough trees are causing problems with the sidewalks.

Additionally for 2023, the Borough is planning for the milling and resurfacing of approximately fourteen streets throughout the Borough with Capital Funds.

## Parks and Recreation – Dennis Jackson, Jenn DeJesso, Directors

Although the Recreation Department was faced with challenges in the last year due to the pandemic and Hurricane Ida, we continue planning and building a stronger Parks and Recreation Department.

We have a new website, new programs, and have extended recreation activities to high school freshmen.

In an effort to create synergy within our community, we've strengthened our relationship with the board of education and have been working together to promote the Recreation programs.

We have also partnered on a quarterly newsletter that is distributed to all residents in the Borough and features a full informational page with all Recreation and Mayor's Special Events.

Recreation's basketball program had good registration numbers this year. We experienced quite a few scheduling challenges due to some Covid outbreaks, but we were able to have some very exciting championship games in the newly renovated middle school gym.

Recreation's Baseball/Softball enrollment was slow to start, but after a spirited marketing campaign within the schools, we saw our highest enrollment in recent years. Also, we successfully re-ignited our softball program which featured four teams at the junior girl's level.

After having Passe field destroyed in 2021 by Hurricane Ida, we were able to have it completely repaired and resume our games at that location.

Summer Camp is another one of our successful programs with an enrollment this year of 150 children. We strive to have a quality product that remains affordable to our community.

We are currently in the process of refurbishing the Vermeule Playground with new playground equipment and a new mulch surface to improve safety.

The Community Center Christmas light display this year was our biggest ever, and was well received by residents. Our Santa Comes to Town event was a big hit as usual.

We are in the process of applying for grant funding to refurbish the basketball courts in Green Acres Park.

We plan to continue working with Somerset County to apply for grants to improve the Vermeule site and plan for future improvements at the former Villa Maria site once that land comes under Borough jurisdiction.

A significant highlight this year was the return of approximately 12 acres of open space along the Green Brook which was formerly under a 99 year lease with Union County. That land will remain undeveloped in an effort to alleviate flooding.

## **Sanitary Sewer Grants**

This year we are replacing a section of one of the Borough's oldest sewer lines on Rockview Avenue. Other sewer work is currently taking place on Jefferson Avenue. These projects are partially funded by Federal Community Development Block Grants administered by Somerset County.

We are in the planning stages for a project to rehabilitate sewers on Greenbrook Road. I am glad to announce that we will be receiving \$500,000 in funding through Somerset County to perform this work which will cover the entire cost of this project.

These sewer projects translate to dollars saved by our residents by reducing groundwater infiltration into the sewer lines and mitigating the need for expensive emergency repairs.

## EV's

This year we purchased the Borough's first electric vehicles and charging stations. Four vehicles were purchased for use by the Police and Administrative Departments utilizing \$34,000 in grants from PSE&G and the NJ Board of Public Utilities. These vehicles will save on fuel and maintenance costs over the long term. We will continue to investigate EV's for other Borough vehicles in the future.

## Council/Administration

While I've mentioned a lot of accomplishments, I must add that these are made possible with the support and backing of the Borough Council. The Council and I strive to have a close working relationship in which we can speak frankly and honestly about the issues facing the Borough.

The Council is responsible for funding our initiatives through the operating and Capital budgets. The Council, as the Borough's legislative body, enacts ordinances which have a direct impact on our quality of life.

I'd like to take this opportunity to welcome back Councilmembers Shafer, Given, McIntyre, and Merrill as you begin your four year terms.

I would like to express my appreciation to my Administrator Dave Hollod and my Assistant Katherine Miller. I count on them to carry out the day-to-day duties of my office. Every day brings its own set of issues and I know I can count on them to handle most anything that comes their way.

## Volunteers

Countless volunteer hours go into making our community strong and vital, and a better place to call home. Dozens of our residents help out at recreational events, litter pickup days, serve on

committees, and bring issues to the attention of Borough government. For our part we try to respond to issues in a timely and courteous manner, keep in regular communication with our residents, and generally support all volunteer activities.

Every citizen has a role to play in making North Plainfield a better community. Whether that be a commitment as extensive as serving in local government, or simply bringing issues to our attention, our town works best when everyone takes an active role trying to make it better. So please keep in touch with us as we welcome your ideas and input on issues big and small.

## Conclusion

While we can't predict all of the issues that will arise during the next year, I am confident that, working together as a team, we can face them successfully. Thank you for your support and I wish you and all the citizens of North Plainfield a very Happy and Healthy New Year!

Mr. Hollod acknowledged being a part of a great team consisting of the Council, Mayor and members of the various boards, committees, and commissions. He recognized the Borough's partnership with Somerset County for their continued support, specifically with grants.

Ms. Corzo offered her congratulations to the four re-elected members of the Council. She thanked her colleagues for their vote of confidence as she steps into the Vice President role.

Mr. Merrill wished to underscore Ms. Corzo's sentiments to the four re-elected Council members and wished her well in her new role as Council Vice President. He recognized the passing of Linda Bond-Nelson who had served on the Board of Education for many years.

Ms. Miller expressed her pride to serve on a majority female governing body, noting it as a privilege and an honor.

Ms. Schaefer congratulated Council Vice President Corzo, Council President Stabile and her running mates. She then wished everyone a happy New Year.

Mr. McIntyre thanked Mr. Merrill for his service as Council Vice President and congratulated Vice President Corzo.

Ms. Given acknowledged looking forward to the next four years serving with her fellow Council members.

Council President Stabile congratulated the four re-elected Council members. In terms of governing bodies, this group possesses a real synergy and diversity of backgrounds and experiences. He thanked them for their faith in him as he commences a new term as Council President.
