**AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT ARTICLE I OF THE ADMINISTRATIVE CODE OF THE BOROUGH CODE, ENTITLED “ADMINISTRATIVE CODE”, MORE SPECIFICALLY CHAPTER 2-6, ENTITLED “DEPARTMENT OF ADMINISTRATION,” AND MORE PARTICULARLY § 2-6.5, ENTITLED “ESTABLISHMENT OF PARKS AND RECREATION COMMITTEE,”**

**WHEREAS**, § 2-6.5 of the Borough Code of the Borough of North Plainfield authorizes the Mayor to appoint a Parks and Recreation Committee; and,

**WHEREAS**, after proper investigation, the Mayor’s Office has determined that the Parks and Recreation Committee has performed outstanding work for the benefit of residents of the Borough of North Plainfield; and,

**WHEREAS**, the Mayor’s Office has determined that the Parks and Recreation Committee should be restructured to be able to continue its work in a more streamlined and timely fashion by amending the quorum requirements thereof; and,

**WHEREAS**, the Borough Council finds it necessary and appropriate to amend, revise and supplement § 2-6.5 of the Borough Code regarding the Mayor’s Parks and Recreation Committee to restructure the Parks and Recreation Committee to be able to continue its work in a more streamlined and timely fashion.

**NOW, THEREFORE, BE IT ORDAINED** by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Code of the Borough of North Plainfield be amended, revised and supplemented as to Article I of the Administrative Code of the Borough Code, entitled “Administrative Code”, more specifically Chapter 2-6, entitled

“Department of Administration,” and more particularly § 2-6.5, entitled “Establishment of Parks and Recreation Committee,” as follows:

**§ 2-6.5 Establishment of Parks and Recreation Committee.**

e. Organizational Matters.

1. The Parks and Recreation Committee shall not be deemed to be a recreation commission pursuant to N.J.S.A. 40:12-1 et seq. or N.J.S.A. 40:61-17 et seq., and shall have only those powers and duties as specifically set forth herein or as established by ordinance adopted by the Borough Council.

2. The Parks and Recreation Committee shall have no spending and/or financial authority and no hiring authority.

3. Meetings. The Parks and Recreation Committee shall, at its first meeting each year, set a schedule for the holding of open public meetings and shall annually elect from its membership a Chairperson, Vice Chairperson and Secretary. The Secretary shall arrange for the publication of the schedule of meetings with the Borough Clerk, keep minutes of all meetings and official correspondence and keep complete and detailed records of the Parks and Recreation Committee's activities. The Secretary shall submit a copy of the minutes to the Borough Clerk for public record as soon as they are approved by the Parks and Recreation Committee.

4. Schedule. The Parks and Recreation Committee shall hold periodic public meetings at a time and day determined at the beginning of each year. These meetings shall take place at Borough Hall or at such other suitable public place as it may determine upon notice to the Borough Clerk and to the public. Additional meetings may be called by the Chair at any time, upon written notice to the Borough Clerk, Mayor and to the public.

5. Quorum. A majority of the membership (~~seven members~~) (three (3) members) shall constitute a quorum.

6. Adoption of By-Laws. The Parks and Recreation Committee may adopt its own by-laws for conducting its meetings, a copy of which shall be provided to the Borough Administrator before adoption.

**NOW, THEREFORE, BE IT FURTHER ORDAINED** that this Ordinance shall take effect, after final passage, twenty (20) days following action or inaction by the Mayor as provided by law or an override of a mayoral veto by the Council, whichever is applicable and publication

**AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT  
CHAPTER THREE OF THE BOROUGH CODE, ENTITLED  
“POLICE REGULATIONS,” MORE SPECIFICALLY BY  
AMENDING, REVISING AND SUPPLEMENTING § 3-7 OF THE  
BOROUGH CODE, ENTITLED “DISORDERLY CONDUCT”.**

**WHEREAS**, pursuant to *N.J.S.A. 40:48-1* and *N.J.S.A. 40:48-2*, the governing body of a municipality may make, amend, repeal and enforce such ordinances, regulations, rules and by-laws not contrary to the laws of this State and/or of the United States, as it may deem necessary and proper for the good of government, order and protection of person and property and for the preservation of the public health, safety and welfare of the municipality and its inhabitants and, as may be necessary, to carry into effect the powers and duties conferred and imposed by this subtitle, or by any other law; and,

**WHEREAS**, this grant of authority includes the power to adopt reasonable ordinances for the regulation of any noise which annoys and/or disturbs humans and/or which causes or tends to cause an adverse psychological or physiological effect on humans of the Borough of North Plainfield; and,

**WHEREAS**, the Borough Council has received complaints by email, telephone and at public meetings of late night and excessively loud and disturbing music coming from parties, events, vehicles or other occurrences within the Borough; and,

**WHEREAS**, the Borough Council finds it necessary and appropriate for the regulation of any such noise to amend, revise and supplement Chapter Three of the Borough Code, entitled “Police Regulations,” more specifically by amending, revising and supplementing § 3-7 of the Borough Code, entitled “Disorderly Conduct,” in the Borough of North Plainfield.

**NOW, THEREFORE, BE IT ORDAINED** by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Code of the Borough of North Plainfield be amended, revised and supplemented as to Chapter 3 of the Borough Code, entitled “Police Regulations,” more specifically by amending, revising and supplementing § 3-7 of the Borough Code, entitled “Disorderly Conduct,” as follows:

**§ 3-7 DISORDERLY CONDUCT.**

**§ 3-7.1 Definitions.**

As used in this section:

**AUDIBLE, CLEARLY AUDIBLE OR PLAINLY AUDIBLE**

Shall mean any sound that can be detected by a person using his or her unaided hearing faculties of normal acuity. The detection of a rhythmic bass component of any music is sufficient to verify an audible, clearly audible or plainly audible sound, but a person detecting such sound need not determine a title, specific words or the artist performing the music for such to be audible, clearly audible or plainly audible.

**NOISE**

Shall mean any sound which annoys or disturbs humans or which causes or tends to cause an adverse psychological or physiological effect on humans.

**SOUND**

Shall mean an oscillation in pressure, particle displacement, particle velocity or other physical parameter, in a medium with internal forces that causes compression and rarefaction of that medium. The description of sound may include any characteristics of such sound, including duration, intensity and frequency.

**§ 3-7.2 Loud, Unnecessary or Unusual Noise Prohibited.**

- a. It shall be unlawful for a person to make, continue or cause to be made or continued any loud, unnecessary or unusual noise or any noise which does or is likely to annoy, disturb, injure or endanger the comfort, repose, health, peace or safety of others. It shall be unlawful for a person to cause to be made or continued from any mechanical source, including but not limited to any motor vehicle or system thereof, any loud, unnecessary or unusual noise or any noise which does or is likely to annoy, disturb, injure or endanger the comfort, repose, health, peace or safety of others, except as set forth in this Section.
- b. Radios; Televisions; Phonographs; Instruments. It shall be unlawful for a person to make, continue or cause to be made or continued the playing, use or operation of any radio receiving set, television, amplified or unamplified musical instrument, phonograph or other machine or device for the producing or reproducing of sound in such manner as to disturb the peace, quiet and comfort of neighboring inhabitants or the public. The operation of such a machine or device so that it is clearly audible at a distance of ~~400~~ 50 (fifty) feet from the building in which it is located, or outdoor space in which it is operated, shall be prima facie evidence of a violation of this section. The operation of a nuisance vehicle under Borough Code § 3-19 and/or N.J.S.A. 39:3C-35 so that its sound system is clearly audible at a distance

of fifty (50) feet from the location of any person, or in outdoor space in which it is operated, shall be prima facie evidence of a violation of this section.

- c. Portable Powered Tools, Machines and Devices. It shall be unlawful for a person to make, continue or cause to be made or continued the operation of any portable powered saw, hammer, compressor or other tool, machine or device, whether powered by internal combustion, compressed air or electrical or other power source, in such manner as to disturb the peace, quiet and comfort of neighboring inhabitants or the public except between the hours of 8:00 a.m. to 8:00 p.m. Monday through Thursday, 8:00 a.m. to 8:00 p.m. on Friday and Saturday, and 10:00 a.m. to 8:00 p.m. on Sunday. The operation of such a tool, machine or device so that it is clearly audible at a distance of fifty (50) ~~100~~ feet from the building in which it is located, or outdoor space in which it is operated, shall be prima facie evidence of a violation of this section.
- d. Nothing herein contained shall be construed to prohibit playing ~~by a band or orchestra of~~ music by a band or orchestra, DJ, amplified or unamplified musical instrument, phonograph or other machine or device for the producing or reproducing of sound, in a hall, building or in the open air by any non-profit organization, Board of Education or Borough of North Plainfield for an organized or sponsored program, activity or event, or by any other public program, activity or event, provided, however, that prior written approval therefor has been obtained from the Borough of North Plainfield.
- e. No program, activity or event for which a prior approval under section (d) above has been granted by the Borough of North Plainfield shall commence before 12 noon or end after 8:00pm on Sunday through Thursday, or before 12 noon or end after 9:00pm on Friday or Saturday, including holidays.
- f. A first violation of Borough Code § 3-7.2(a) where the noise is made or continued from any mechanical source, including but not limited to any motor vehicle or system thereof, shall be subject to a fine of no less than \$250.00 or more than \$500.00. A second or subsequent violation where the noise is made or continued from any mechanical source, including but not limited to any motor vehicle or system thereof, shall be subject to a fine of \$500.00. All other of this Section of the Borough Code shall be subject to the general penalties set forth in Borough Code § 1-5, General Penalty.

**NOW, THEREFORE, BE IT FURTHER ORDAINED** that this Ordinance shall take effect, after final passage, twenty (20) days following action or inaction by the Mayor as provided by law or an override of a mayoral veto by the Council, whichever is applicable and publication in accordance with law, unless a resolution is adopted, pursuant to *N.J.S.A. 40:69A-181(b)*, declaring an emergency and providing that this Ordinance shall take effect at an earlier date.

**RESOLUTION OF THE BOROUGH COUNCIL WAIVING  
CERTAIN GARAGE SALE LICENSING ORDINANCES IN

**WHEREAS**, Garage Sales, Yard Sales and Estate Sales are popular in North Plainfield as a means of getting to know neighbors while realizing a modest profit for the sellers; and,

**WHEREAS**, the Mayor and Borough Council have heard requests from the citizenry for a Borough-wide, fee-free weekend garage sale that would appeal to the interests of all Borough residences; and,

**WHEREAS**, North Plainfield Ordinance No. 18-07 calls for a Twenty Dollar (\$20.00) fee to be charged for every garage sale permit issued by the Borough Clerk's Office; due to requests heard from residents throughout North Plainfield, the Borough Council is interested in having the above fee waived for such sales throughout the Borough on Saturday, for a Borough-wide public garage sale; and,

**WHEREAS**, N.P.R.G.O. 4-11.6 regulates the number of signs advertising a garage sale; the Borough Council is interested in having said sign restriction regarding the number of signs allowed to be posted waived for such sales throughout the Borough on Saturday, June 22, 2024 and Sunday, June 23, 2024 (Rain date June 29-30, 2024) and Saturday, October 5, 2024 and Sunday, October 6, 2024 for a Borough-wide public garage sale.

**NOW, THEREFORE, BE IT RESOLVED** that this Borough-wide garage sale would not impact residents' three (3) per year paid permit allotment.

**BE IT FURTHER RESOLVED** that the hours of the town-wide garage sale would run from 9:00 a.m. until 4:00 p.m. local time on both Saturday and Sunday.

**BE IT FURTHER RESOLVED** by the Mayor and Borough Council of the Borough of North Plainfield that for purposes of allowing a Borough-wide garage sale on Saturday, June 22, 2024 and Sunday, June 23, 2024 and Saturday, October 5, 2024 and Sunday, October 6, 2024 the fee for such a two (2) day sale per Ordinance No. 18-07 shall be waived for this event.

FINAL PAYMENT NO. 3 (FINAL) TO VORTEX SERVICES,  
L.L.C. AND THE CLOSING OUT AND CHANGE ORDER NO. 1  
OF THE CONTRACT AND THE RELEASE OF RETAINAGE  
FOR THE ROCKVIEW AVENUE SANITARY SEWER  
REHABILITATION PROJECT.**

**WHEREAS**, the Borough of North Plainfield previously awarded a contract for the Rockview Avenue Sanitary Sewer Rehabilitation Project (hereinafter referred to as the “Project”) to Vortex Services, L.L.C. (hereinafter referred to as the “Contractor”); and,

**WHEREAS**, Bryan Oakes, P.E., of Mott McDonald, the Borough’s Engineer for the Project, on behalf of the Borough, by letter dated May 31, 2024, a copy of which is on file in the office of the Acting Borough Clerk and made a part hereof, has reviewed the Contractor’s submission for Payment No.3(Final) and CHANGE Order No. 1; and,

**WHEREAS**, the original contract price for the Project was One Hundred Two Thousand Nine Hundred Fourteen Dollars (\$102,914.00), which has been adjusted by the Final Contract Completed Cost, through change Order No. 1, decreasing the final contract amount by Seven Thousand, One Hundred Sixteen Dollars and Two Cents (\$7,116.02) to a final Contract Price of Ninety Five Thousand Seven Hundred Ninety Seven Dollars and Ninety Eight Cents (\$95,797.98); and,

**WHEREAS**, the Contractor has submitted said Final Payment No.3, adjusted by the above amount, to a final Contract Balance due in the total amount of One Thousand Nine Hundred Fifteen Dollars and Ninety-Six Cents (\$1,915.96) plus the release of any and all of the Contractor’s retained funds held by the Borough for the Project; and,

**WHEREAS**, in accordance with the Contract, the Contractor has submitted a one (1) year Maintenance Bond in the amount of Ninety-Five Thousand Seven Hundred Ninety-Seven Dollars and Ninety Eight Cents (\$95,797.98), with an effective date of May 6, 2024; and,

**WHEREAS**, Director of Law/Borough Attorney Eric M. Bernstein, Esquire and the offices of Eric M. Bernstein & Associates, L.L.C. have reviewed the Borough’s Engineer on this Project and the Contractor’s submissions and accept same based on the recommendations of the Borough Engineer.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the request for Final Payment No.3



(Final) and Change Order No. 1 and the Closeout of the Rockview Avenue Sanitary Sewer Rehabilitation Project is approved with Vortex Services, L.L.C., whose main offices are located at 210 Bennett Road, Freehold, New Jersey 07728, in the total amount of One Thousand Nine Hundred Fifteen Dollars and Ninety Six Cents (\$1,915.96) plus the release of any and all of the Contractor's retained funds held by the Borough for the Project, which Final Payment Request and Closeout request is incorporated herein by reference as if same was fully set forth within and payment for same is authorized to be made to the Contractor, without the need for any further action of this Borough Council; and,

## CID Monthly Report

### A Sample of Investigations & Arrests

On April 3, 2024, a borough resident came to headquarters and reported that on March 26, 2024 he was on Facebook Marketplace and was attempting to purchase 2 wrestling tickets. He agreed to purchase 2 tickets for \$1,000.00 from an unknown male subject and paid him via Zelle. Continuing with the chat throughout the week, another unknown subject joined in and said if he wants the tickets he needs to pay more money. The victim paid an additional \$2,500.00 through the Zelle account and \$2,850.00 through an Apple Pay account, totaling \$6,350.00. The victim never received the tickets and at this point he believes this is a scam so he decided to stop payment to these unknown individuals.

On Monday, April 8, 2024 at 1248 hrs., patrol responded to the area of Race Street and Watchung Avenue on a report of a parking complaint. While on scene, a male approached the officer and reported that he was robbed at gun point over the weekend. The victim, a Plainfield resident, said that on Saturday, April 6, 2024, two unknown males robbed him at gun point. He said he parked his BMW in the area of Fairview Avenue just after 11:00 pm. While sitting in the driver seat of his vehicle and talking on the phone, two Hispanic males wearing dark clothing and masks covering their faces, approached his vehicle from the rear and one of the males pointed what he believes to be

a handgun at his temple. One male suspect exclaimed "don't look at me" and proceeded to go through his front pants pocket, removing \$500.00 in cash. The males then fled on foot in an unknown direction. He did not call the police because he was scared. CID was notified and is investigating.

On April 29, 2024 at 2135 hrs., two residents of the borough, a husband and wife, came to headquarters and reported that at 1625 hrs., they received a call from an unknown number and the female caller identified herself as an "Immigration Officer". The female spoke to her in Spanish and advised that she had been issued a \$1,800.00 fine. The victim was instructed by the female to contact another "officer" at a different number for instructions. The victim did as she was told and called another alleged "officer". The "officer" told the victim that she must send \$900.00 via MoneyGram and \$900.00 via Western Union to a person and phone number in Lima, Peru. The victim complied and sent the money, a picture of both money wire confirmations, and called the fake officer back. The victim's husband was suspicious that this was fraud and told his wife. The fake officers then told the victims that they were just issued a \$900.00 fee for the comment and that they would take away his work permit and call DCPD and have his daughters taken away. He then called his lawyer who told him that he was scammed.
