**AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT
THE BOROUGH CODE OF THE BOROUGH OF NORTH PLAINFIELD,
CHAPTER VII ENTITLED, "TRAFFIC",
SECTION 7-7 ENTITLED,
"LOADING ZONES",
MOST NOTABLY, SCHEDULE XI, ENTITLED
"SCHEDULE XI LOADING ZONES."**

WHEREAS, the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey believes that it is in the best interest of the Borough to revise, amend and supplement Section 7-7 of the Borough Code of the Borough of North Plainfield, entitled "Loading Zones"; and,

WHEREAS, the Borough of North Plainfield, County of Somerset, State of New Jersey is authorized by State law to make rules limiting on street parking to certain hours of the day so that those areas can be used as a "loading zone"; and,

WHEREAS, the Borough of North Plainfield, County of Somerset, State of New Jersey has determined that the public health, welfare and safety are protected by limiting the use of certain on street parking so that motor vehicles bearing commercial license plates can load and unload goods and/or merchandise without blocking traffic as set forth below.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that Schedule XI of Chapter VII, Section 7-7 of the Borough Code of the Borough of North Plainfield, entitled "Loading Zones", is hereby revised, amended and supplemented by expanding the following loading zone in Schedule XI:

SCHEDULE XI LOADING ZONES

SCHEDULE XI, LOADING ZONES			
A. In accordance with the provisions of Section 7-7, the following described locations are hereby designated as loading zones.			
<i>Name of Street</i>	<i>Sides</i>	<i>Direction</i>	<i>Location</i>
Somerset Street	West	Southerly	Starting at a point 30 feet north of the northerly curb line of Fairview Avenue and extending to a point 60 feet north therefrom.
Warren Street	West	Southerly	Starting at a point 25 feet north of the northerly curb line of Pearl Street and ending 22 feet north therefrom

SCHEDULE XI, LOADING ZONES
B. Loading Zones Between the Hours of 8:00 a.m. and 5:00 p.m.
<p>Harmony Street on the north side, starting at a point 220 <u>150</u> feet east of the easterly curb line of Somerset Street to a point 106 <u>190</u> feet east therefrom.</p> <p>No stopping or standing except in accordance with the provisions of <u>N.J.S.A. 39:4-139</u> shall be permitted between the hours of 8:00 a.m. and 5:00 p.m. on Mondays through Fridays.</p> <p>*Additions in text indicated by <u>underline</u>; deletions by strikeouts.</p>

NOW, THEREFORE, BE IT FURTHER ORDAINED that:

1. Proper signage shall be erected after receipt of any approvals required pursuant to state or county regulations and requirements.
2. All ordinances or portions of ordinances that are inconsistent with this Ordinance shall be repealed as to their inconsistencies only.
3. If any provision or paragraph of this Ordinance shall be held invalid by any court of competent jurisdiction, the same shall not affect the other provisions or paragraphs of this Ordinance, except so far as the provision or paragraph so declared invalid shall be separable from the remainder or any portion thereof.

4. This Ordinance shall take effect, after final passage, twenty (20) days following action or inaction by the Mayor as provided by law or an override of a mayoral veto by the council, whichever is applicable and publication in accordance with law, unless a resolution is adopted, pursuant to *N.J.S.A. 40:69A-181(b)*, declaring an emergency and providing that this Ordinance shall take effect at an earlier date.
