**AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT
THE BOROUGH CODE OF THE BOROUGH OF NORTH PLAINFIELD,
CHAPTER VII ENTITLED, "TRAFFIC,"
SECTION 7-3 ENTITLED,
"PROHIBITED PARKING,"
MOST NOTABLY,
SECTION 7-3.5, ENTITLED
"PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS,"
SCHEDULE III, "PARKING PROHIBITED CERTAIN HOURS."**

WHEREAS, the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey believes that it is in the best interest of the Borough to amend, revise and supplement Section 7-3 of the Borough Code of the Borough of North Plainfield, entitled "Prohibited Parking"; and,

WHEREAS, the Borough of North Plainfield, County of Somerset, State of New Jersey is authorized by State law to make rules prohibiting on-street parking on certain sections of public roads during certain times within the Borough of North Plainfield; and,

WHEREAS, the Borough of North Plainfield, County of Somerset, State of New Jersey has determined that the public health, welfare and safety are protected by prohibiting the use of certain on-street parking along certain streets of the Borough of North Plainfield at certain times.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that Schedule III of Chapter VII, Section 7-3.5 of the Borough Code of the Borough of North Plainfield, entitled "Parking Prohibited During Certain Hours on Certain Streets," is hereby amended, revised and supplemented by prohibiting on-street parking on the following streets in Schedule III as follows:

SCHEDULE III PARKING PROHIBITED CERTAIN HOURS

In accordance with the provisions of Subsection 7-3.5, no person shall park a vehicle between the hours specified upon any of the following described streets or parts of streets.

NOW, THEREFORE, BE IT FURTHER ORDAINED that:

- Proper signage shall be erected or removed after receipt of any approvals required pursuant to state or county regulations and requirements.
- All ordinances or portions of ordinances that are inconsistent with this Ordinance shall be repealed as to their inconsistencies only.
- If any provision or paragraph of this Ordinance shall be held invalid by any court of competent jurisdiction, the same shall not affect the other provisions or paragraphs of this Ordinance, except so far as the provision or paragraph so declared invalid shall be separable from the remainder or any portion thereof.
- This Ordinance shall take effect, after final passage, twenty (20) days following action or inaction by the Mayor as provided by law or an override of a mayoral veto by the Council, whichever is applicable and publication in accordance with law, unless a resolution is adopted, pursuant to *N.J.S.A. 40:69A-181(b)*, declaring an emergency and providing that this Ordinance shall take effect at an earlier date.
