

NOTICE OF PENDING ORDINANCE

NOTICE IS HEREBY GIVEN

that at a meeting of the Council of the Borough of North Plainfield held on January 14, 2019 there was introduced and read for the first time, and passed on such first reading, an ordinance, a true copy whereof is printed below and that said Council did then and there fix the regular meeting of said Council to be held on February 11, 2019 at 7:30 p.m. or as soon thereafter as the matter may be heard, and the Borough Council Chambers, 263 Somerset Street, North Plainfield, New Jersey as the place when and where said ordinance will be further considered for final passage, at which time and place, or at any time and place to which such meeting shall from time to time be adjourned, all persons interested will be given an opportunity to be heard concerning such ordinance.

The said ordinance as introduced and passed on first reading as aforesaid is in the following words and figures:

**AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT
THE BOROUGH CODE OF THE BOROUGH OF NORTH PLAINFIELD,
CHAPTER VII ENTITLED, "TRAFFIC,"
SECTION 7-15 ENTITLED,
"HANDICAPPED PARKING,"
MOST NOTABLY,
SCHEDULE XXI, "ON STREET HANDICAPPED PARKING."**

WHEREAS, the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey believes that it is in the best interest of the Borough to amend, revise and supplement Section 7-15 of the Borough Code of the Borough of North Plainfield, entitled "Handicapped Parking"; and,

WHEREAS, the Borough of North Plainfield, County of Somerset, State of New Jersey is authorized by State law to create handicapped parking spots on certain sections of public roads within the Borough of North Plainfield; and,

WHEREAS, the Borough of North Plainfield, County of Somerset, State of New Jersey has determined that the public health, welfare and safety are protected by creating handicapped parking spots along certain streets within the geographic boundaries of the Borough of North Plainfield.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that Schedule XXI of Chapter VII, Section 7-15 of the Borough Code of the Borough of North Plainfield, entitled “Handicapped Parking,” is hereby amended, revised and supplemented by creating handicapped parking spots on the following streets in Schedule XXI:

SCHEDULE XXI ON STREET HANDICAPPED PARKING

In accordance with the provisions of subsection 7-15.1, the following street locations, as further described on a sketch on file with the Borough Clerk, are hereby designated as Handicapped Parking spaces:

SCHEDULE XXI, ON STREET HANDICAPPED PARKING	
<i>Name of Street</i>	<i>Location</i>
<u>Fairview Avenue</u>	<u>South side, beginning at a point 75 feet from the extended easterly curb line to Watchung Avenue to a point 50 feet therefrom.</u>
Grove Street	North side, beginning at a point 50 feet from the extended northerly curb line of Dupont Street to a point 22 feet therefrom.
Harrington Avenue	East side, beginning at a point 120 feet south of the southerly curb line of Greenbrook Road to a point 22 feet therefrom.
Rockview Ave.	North side, beginning at a point 70 feet west of the extended curb of Grove Street and extending 25 feet therefrom. (Ord. No. 2015-10; Ord. No. 2016-02)
Somerset Street	West side, beginning at a point 97 feet north of the extension of the north curb line of Lincoln Place and extending 22 feet therefrom.
Stone Street	East side, beginning at a point 234 feet south from the extended southerly curb line of Union Street to a point 22 feet therefrom. (Ord. No. 2017-15)

27 Vine Street	West side, beginning at a point 165 feet south of the southerly curb line of Park Place to a point 22 feet therefrom.
Walnut Street	South side, beginning at a point 38 feet east of the easterly curb line of Wilson Avenue and continuing 22 feet east thereof.
Wilson Avenue	East side, beginning at a point 130 feet south of the southerly curb line of Walnut Street to a point 22 feet south therefrom.

NOW, THEREFORE, BE IT FURTHER ORDAINED that:

1. Proper signage shall be erected or removed after receipt of any approvals required pursuant to state or county regulations and requirements.
2. All ordinances or portions of ordinances that are inconsistent with this Ordinance shall be repealed as to their inconsistencies only.
3. If any provision or paragraph of this Ordinance shall be held invalid by any court of competent jurisdiction, the same shall not affect the other provisions or paragraphs of this Ordinance, except so far as the provision or paragraph so declared invalid shall be separable from the remainder or any portion thereof.
4. This Ordinance shall take effect, after final passage, twenty (20) calendar days following action or inaction by the Mayor as provided by law or an override of a mayoral veto by the Council, whichever is applicable and publication in accordance with law, unless a resolution is adopted, pursuant to *N.J.S.A. 40:69A-181(b)*, declaring an emergency and providing that this Ordinance shall take effect at an earlier date.
