The following is a report of the activities of the North Plainfield Police Department for the month. The Divisions of the Department divide the report.

ADMINISTRATION:

Staffing:

The Police Department is operating below its authorized strength of 48 sworn Officers, and 6 fulltime civilian personnel. Staffing and deficiencies:

- 3 police officers
- 1 Lieutenant's position
- 2 administrative assistants (chief and records) have been reduced to 29 hour part-time positions.

Injured Officers:

- On June 6, Detective Everett returned to work after he sustained serious burns to his hands and stomach when a battery in his pocket exploded during his lunch break on May 6. As a result of the injury, he was out of work for a total of 3 calendar days in the month of June, and 20 days in total.

Promotions, New Hires and Retirements

- On June 30, Officer Aivaliotis retired after 28 years of service with the department.

Community Outreach

The Summer Teen Evening Program “STEP” program started for local youth in June overseen by the Community Policing Unit. Both Detectives attended the Municipal Alliance Meeting in June. With the conclusion of the school year the DARE graduation commenced with 251 children graduating this year. Detective Fowler assisted with both the eighth grade graduation and the High School graduation. Detective Domizi attended the Watchung Presbyterian Church Community Services Health Fair. 32 first time false alarm notification letters were sent out along with 8 false alarm warning notices.

Narcotics Strike Force

During June members of the Narcotics Strike Force spent approximately 52 man hours in the Boro doing surveillance and gathering information on narcotic activity. Officer Kropewnicki attended the week long New Jersey Narcotics Enforcement Officers Association week long training. One investigation this month resulted in the arrest of a male making a delivery of a quantity of Heroin.

Other Matters

During June the Detective Bureau did the following background investigations; two Motor Vehicle Sales, One raffle, two Firearms and one taxi business owner investigation. One RAPID registration was also completed.

Adjudications & Judicial Proceedings

On June 6, 2016 Joyce Lebron was sentenced to three years in prison for a burglary and theft from an unlocked vehicle by the Honorable Judge Cawtherqak of the Somerset County Superior Court.

On June 17, 2016 Josue Carranza-Garcia was sentenced to one year in prison for assault with a weapon by the Honorable Judge Jones of the Somerset County Superior Court.

We are required by the Rules of Court to include herein a statement explaining that the charges are merely an accusation and that the defendants are presumed innocent until and unless proven guilty.
