No Proposals will be accepted after said hour. **The contract scope will be the installation of natural gas unit heaters in (3) bays of the Borough DPW facility, the replacement of the existing boiler and all associated piping, electrical, vents, supports, etc. The scope of work also includes the base bid limited ceiling improvements including insulation and sheetrock in (2) of the three existing bays. Supplemental bid work includes the complete insulation and sheetrock installation for two of the existing bays. The contract will allow sixty (60) calendar days for completion of the work from the notice to proceed. Notice to proceed will be issued on or about <b>October 1, 2015**. Proposals shall be made on the forms provided and made part of the Contract Documents, which shall be submitted intact. A certified check or cashier's check made payable to the order of the Borough of North Plainfield, or a duly executed Bid Bond, in the amount of ten (10) percent (%) of each bid, but in no case in excess of \$20,000.00 must be deposited by the Bidder together with a Surety Consent evidencing that he can obtain the required Performance Bond.

The successful Bidder shall be required to comply with requirements of <u>N.J.S.A.</u> 10:5-31 et seq. and <u>N.J.A.C.</u> 17:27, and deliver to the Borough an executed Performance Bond of a responsible indemnity company authorized to do business in the State of New Jersey.
